## 8 INTRODUCTION

9 SECTION 1.1. The appropriations made in this act are for maximum amounts 10 necessary to provide the services and accomplish the purposes described in the budget. Savings 11 shall be effected where the total amounts appropriated are not required to perform these 12 services and accomplish these purposes and, except as allowed by the State Budget Act, or this 13 act, the savings shall revert to the appropriate fund at the end of each fiscal year as provided in 14 G.S. 143C-1-2(b).

SECTION 1.2. This act shall be known as "The Current Operations and Capital
Improvements Appropriations Act of 2010."

12	<b>SECTION 7.5.</b> If any section or provision of this act is declared unconstitutional or
13	invalid by the courts, it does not affect the validity of this act as a whole or any part other than
14	the part so declared to be unconstitutional or invalid.

# 16 **EFFECTIVE DATE**

17SECTION 7.6. Except as otherwise provided, this act becomes effective July 1,182010.
