## A BILL TO BE ENTITLED

## 2 AN ACT TO IMPROVE PYROTECHNICS SAFETY IN NORTH CAROLINA.

3 The General Assembly of North Carolina enacts: 4

SECTION 1. G.S. 14-410 reads as rewritten:

5 "§ 14-410. Manufacture, sale and use of pyrotechnics prohibited; exceptions; permit 6 required; sale to persons under the age of 16 prohibited.

7 It-Except as otherwise provided in this section, it shall be unlawful for any (a) 8 individual, firm, partnership or corporation to manufacture, purchase, sell, deal in, transport, 9 possess, receive, advertise, use-use, handle, exhibit, or cause to be discharged discharge any 10 pyrotechnics of any description whatsoever within the State of North Carolina: provided, however, that itCarolina. 11

12 It shall be permissible for pyrotechnics to be exhibited, used-used, handled, or (a1) 13 discharged at concerts or public exhibitions, such as fairs, carnivals, shows of all descriptions 14 and public celebrations: provided, further, that the use of said pyrotechnics in connection with 15 concerts or public exhibitions, such as fairs, carnivals, shows of all descriptions and public 16 celebrations, shall be under supervision of experts within the State, provided all of the 17 following apply:

The exhibition, use, or discharge is at a concert or public exhibition. (1)

- All individuals who exhibit, use, handle, or discharge pyrotechnics in (2)connection with a concert or public exhibition have completed the training required under G.S. 58-82A-2 and are under the direct supervision and control of a display operator who holds a display operator permit issued by the State Fire Marshal under G.S. 58-82A-3. The display operator must be present at the concert or public exhibition and must personally direct all aspects of exhibiting, using, handling, or discharging the pyrotechnics.
- The display operator has who have previously secured written authority 26 (3)under G.S. 14-413 from the board of county commissioners of the county, or 27 the city if authorized under G.S. 14-413(a1), in which said-the pyrotechnics 28 29 are to be exhibited, used or discharged. Written authority from the board of 30 commissioners or city is not required, however, required under this 31 subdivision for a concert or public exhibition authorized by provided the 32 display operator has secured written authority from The University of North Carolina or the University of North Carolina at Chapel Hill under 33 34 G.S. 14-413, and pyrotechnics are exhibited conducted on lands or buildings 35 in Orange County owned by The University of North Carolina or the University of North Carolina at Chapel Hill, but such exhibition, use, or 36

4	(a2) Notwithstanding any provision of this section, it shall not be unlawful for a common
5	carrier to receive, transport, and deliver pyrotechnics in the regular course of its business.

8	(b) Notwithstanding the provisions of G.S. 14-414, it shall be unlawful for any
9	individual, firm, partnership, or corporation to sell pyrotechnics as defined in G.S. 14-414(2),

12	(1) <u>Concert or public exhibition. – A fair, carnival, show of any description, or</u>

17	<b>SECTION 2.</b> G.S. 14-413 is amended by adding a new subsection to read:
18	"(d) <u>A board of county commissioners or the governing board of a city shall not issue a</u>
19 20	permit under this section unless the display operator provides proof of insurance in the amount
20 21	of at least five hundred thousand dollars (\$500,000) or the minimum amount required under the
21	North Carolina State Building Code pursuant to G.S. 143-138(e), whichever is greater. A board of county commissioners or the governing board of a city may require proof of insurance that
22	exceeds these minimum requirements."
23 24	<b>SECTION 3.</b> Chapter 58 of the General Statutes is amended by adding a new

31	(1) Individuals who assist a display operator with the exhibition, use, handling,
32	or discharge of pyrotechnics in connection with a concert or public

34	(2) Individuals seeking to obtain a display operator permit under this Article.
35	(b) <u>Definitions. – The definitions in G.S. 14-410 apply in this Article.</u>

38	An individual may not use, handle, exhibit, or discharge pyrotechnics in connection with a
39	concert or public exhibition, as allowed under Article 54 of Chapter 14 of the General Statutes,

41	Commissioner of Insurance through the Office of State Fire Marshal or meets all of the
