General Assembly of North Carolina Session 2009 SECTION 3. G.S. 130A-248(d) reads as rewritten: 1 2 "(d) The Department shall charge each establishment subject to this section, except 3 nutrition programs for the elderly administered by the Division of Aging of the Department of 4 Health and Human Services, establishments that prepare and sell meat food products or poultry 5 products, and public school cafeterias, an annual fee of fifty dollars (\$50.00). cafeterias, a fee of fifty dollars (\$50.00) for each permit issued. This fee shall be reassessed annually for 6 7 permits that do not expire. The Commission shall adopt rules to implement this subsection. 8 Fees collected under this subsection shall be used for State and local food, lodging, and 9 institution sanitation programs and activities. No more than thirty-three and one-third percent 10 (33 1/3%) of the fees collected under this subsection may be used to support State health 11 programs and activities." 12 **SECTION 4.** Section 5 of S.L. 2007-438 reads as rewritten: 13 "SECTION 5. This act becomes effective 1 September 2007 and applies to all nutrient 14 offset payments, including those set out in 15A NCAC 2B .0240, as adopted by the Environmental Management Commission on 12 January 2006. The fee schedule set out in 15 Section 1 of this act expires 1 September 2009.on the effective date of the rules adopted by the 16 17 Environmental Management Commission pursuant to Section 2 of this act."

18 SECTION 5. Section 3 of this act becomes effective July 1, 2009. Sections 1, 2, 4,
19 and 5 of this act are effective when this act becomes law.
