A person may not participate under a fictitious 3 or assumed name in any match unless the person has first registered the name with the 4 Commission. 5 (c) Surety Bond. - An applicant for a promoter's license must submit, in addition to any other forms, documents, or exhibits requested by the Commission, a surety bond payable to the 6 7 Commission for the benefit of any person injured or damaged by (i) the promoter's failure to 8 comply with any provision of this Article or any rules adopted by the Commission or (ii) the 9 promoter's failure to fulfill the obligations of any contract related to the holding of a boxing event. The surety bond shall be issued in an amount to be no less than ten thousand dollars 10 (\$10,000). The amount of the surety bond shall be negotiable upon the sole discretion of the 11 Commission. All surety bonds shall be upon forms approved by the Secretary of Commerce 12 13 and supplied by the Commission. 14 (d) Permit. – A permit issued to a promoter under this Article is valid for a single match. An applicant for a permit shall file with the Commission the appropriate nonrefundable 15 fee and any forms or documents the Commission may require. 16 17 "§ 143-659.6. | 20 | to the North Carolina Athletics Commission in accordance with G.S. 143-659.3, as enacted in |
| 21 | Section 3 of this act. |
| 22 | SECTION 5. This act is effective when it becomes law. |
