BILL SUMMARY:

The proposed legislation amends G.S. 7A-305(a1) to provide that court costs apply to counterclaims to actions brought under G.S. Chapter 50B. The proposed legislation also provides that costs do not apply when the additional, subsequent amendment or counterclaim is limited to requests for relief authorized under G.S. Chapter 50B. This act becomes effective October 1, 2010. *Source: Bill Digest H.B. 1874 (05/19/0201)*

ASSUMPTIONS AND METHODOLOGY:

Judicial Branch

The Administrative Office of the Courts' (AOC) data reveals the following statistics regarding responses to 50B domestic violence protective orders:

Under the proposed legislation, these counterclaims would now be subject to the \$73 General Court of Justice civil district filing fee, the \$4 judicial phone systems fee, and the \$16 local facilities fee. Using the 2009 number of cases as a conservative estimate, revenue would be as follows:
