2 AN ACT TO TRANSFER THE DIVISION OF FOREST RESOURCES AND THE 3 FORESTRY COUNCIL OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO THE DEPARTMENT OF AGRICULTURE AND 4 5 CONSUMER SERVICES AND TO MAKE CONFORMING CHANGES. 6 The General Assembly of North Carolina enacts: 7 SECTION 1.(a) The Division of Forest Resources is transferred from the 8 Department of Environment and Natural Resources to the Department of Agriculture and 9 Consumer Services with all the elements of a Type I transfer as defined by G.S. 143A-6. 10 **SECTION 1.(b)** G.S. 143B-279.3(a) reads as rewritten: 11 All functions, powers, duties, and obligations previously vested in the following "(a) subunits of the following departments are transferred to and vested in the Department of 12 Environment and Natural Resources by a Type I transfer, as defined in G.S. 143A-6: 13 14 15 (6)Forest Resources Division, Department of Natural Resources and 16 **Community Development.** 17 18 **SECTION 1.(c)** Article 7 of Chapter 143A of the General Statutes is amended by 19 adding a new section to read: 20 "§ 143A-65.1. Division of Forest Resources; transfer. The Division of Forest Resources is transferred from the Department of 21 (a) 22 Environment and Natural Resources to the Department of Agriculture and Consumer Services 23 with all the elements of a Type I transfer as defined by G.S. 143A-6. 24 (b) The Department of Agriculture shall have charge of the work of forest maintenance, 25 forest fire prevention, reforestation, and the protection of lands and water supplies by the preservation of forests; it shall also have the care of State forests and parks, and other 26 27 recreational areas now owned or to be acquired by the State, including the lakes referred to in G.S. 146-7." 28 29 SECTION 2.(a) All functions, powers, duties, and obligations previously vested in 30 the Forestry Council are transferred from the Department of Environment and Natural Resources to and vested in the Department of Agriculture and Consumer Services by a Type II 31 32 transfer, as defined in G.S. 143A-6. 33 SECTION 2.(b) G.S. 143B-279.3(b) reads as rewritten: 34 All functions, powers, duties, and obligations previously vested in the following "(b) commissions, boards, councils, and committees of the following departments are transferred to 35
