A BILL TO BE ENTITLED 1 2 AN ACT AMENDING THE LAWS REGULATING IRRIGATION CONTRACTORS TO 3 PROVIDE SUBSTANTIVE REQUIREMENTS FOR LICENSING CORPORATIONS, TO 4 PROVIDE FOR THE ISSUANCE OF LICENSES TO NONRESIDENTS, TO CLARIFY 5 THE FEE STRUCTURE, AND TO MAKE OTHER CONFORMING CHANGES. 6 The General Assembly of North Carolina enacts: 7 **SECTION 1.** G.S. 89G-3 reads as rewritten: 8 "§ 89G-3. Exemptions. 9 The provisions in this Chapter shall not apply to: 10 Any federal or State agency or any political subdivision performing (1) 11 irrigation construction or contracting work on public property. Any property owner who performs irrigation construction or irrigation 12 (2) contracting work on his or her own property. 13 14 A landscape architect registered under Chapter 89A of the General Statutes. (3) A professional engineer licensed under Chapter 89C of the General Statutes. 15 (4) 16 Any irrigation construction or irrigation contracting work where the price of (5) all contracts for labor, material, and other items for a given jobsite is less 17 18 than two thousand five hundred dollars (\$2,500). 19 Any person performing irrigation construction or irrigation contracting work (6) 20

- for temporary irrigation to establish vegetative cover for erosion control. Any person performing irrigation construction or irrigation contracting work (7)
 - to control dust on commercial construction sites or mining operations. Any person performing irrigation construction or irrigation contracting work (8) for use in agricultural production, farming, or ranching, including land
 - application of animal wastewater. Any person performing irrigation construction or irrigation contracting work (9) for use in commercial sod production.
 - Any person performing irrigation construction or irrigation contracting work (10)for use in the commercial production of horticultural crops, including nursery and greenhouse operators.
 - A general contractor licensed under Article 1 of Chapter 87 of the General (11)Statutes. Statutes who possesses a classification under G.S. 87-10(b) as a building contractor, a residential contractor, or a public utilities contractor when the contractor uses the contractor's own employees to perform irrigation construction or irrigation contracting work. A public utilities



contractor exempted by this subdivision may perform only the activities 1 2 described in G.S. 87-10(b)(3)a. 3 A wastewater contractor certified under Article 5 of Chapter 90A of the (12)4 General Statutes who performs only the construction of or repair to a 5 wastewater dispersal system. A public utility contractor licensed under Article 1 of Chapter 87 of the 6 (13)7 General Statutes. 8 A plumbing contractor licensed under Article 2 of Chapter 87 of the General (14)Statutes who performs only the following work: installation, repairs, or 9 maintenance of water mains, water taps, service lines, water meters, or 10 11 backflow prevention assemblies supplying water for irrigation systems; or 12 repairs to an irrigation system. 13 Any person performing irrigation construction or irrigation contracting work (15)for a golf course. 14 Any personfull-time employee of a homeowners association maintaining or 15 (16)repairing an irrigation system owned by the homeowners association of a 16 17 planned community and located within the planned community's common elements as defined in G.S. 47F-1-103." 18 19 **SECTION 2.** G.S. 89G-5(11) reads as rewritten: 20 "§ 89G-5. Powers and duties. 21 The Board shall have the following powers and duties: 22 23 (11)To require licensees to file and maintain an adequate surety bond.bond or 24 letter of credit. 25 26 **SECTION 3.** Chapter 89G of the General Statutes is amended by adding the 27 following new sections to read: 28 "§ 89G-6.1. Corporations; partnerships; persons doing business under trade name. 29 The Board may issue a license in the name of a corporation if the corporation pays 30 the license fee required by G.S. 89G-10 and complies with the following: One or more officers or full-time employees, or both, empowered to act for 31 (1) 32 the corporation are individuals licensed under this Chapter. 33 Only the officers or employees described in subdivision (1) of this (2) 34 subsection execute contracts for irrigation construction in the name of a 35 corporation and exercise direct supervision over the work performed 36 pursuant to the contract. 37 The Board may issue a license in the name of a limited liability company if the (b) 38 company pays the fee required by G.S. 89G-10 and complies with the following: 39 One or more managers or executives, as defined in G.S. 57C-1-03, or (1) 40 full-time employees, or a combination thereof, are individuals licensed under 41 this Chapter. 42 Only the managers, executives, or employees described in subdivision (1) of (2) this subsection execute contracts for irrigation construction in the name of 43 44 the limited liability company and exercise direct supervision over the work performed pursuant to the contract. 45 The Board may issue a license in the name of a partnership if the partnership pays 46 47 the fee required by G.S. 89G-10 and complies with the following: 48 One or more general partners or full-time employees empowered to act for (1) the partnership are individuals licensed under this Chapter. 49 50 Only the partners or employees described in subdivision (1) of this **(2)** subsection execute contracts for irrigation construction in the name of the 51

- The Board may issue a license in an assumed or designated trade name if the owner (d) of the business pays the fee required by G.S. 89G-10 and complies with the following:

The owner or one or more full-time employees empowered to act for the (1) owner is an individual licensed under this Chapter.

Only the persons described in subdivision (1) of this subsection execute (2) contracts for irrigation construction in the assumed or designated trade name of the business and exercise direct supervision over the work performed pursuant to the contract.

When the Board issues a license under this section, the Board shall indicate on the (e) license the name and license number of the individual licensee connected to the corporation, partnership, or business conducted under an assumed or designated trade name.

A person licensed pursuant to this section shall exercise direct supervision over a contract for irrigation construction until the contract is completed.

When an individual licensee, other than a sole proprietor, executes a contract for irrigation construction on behalf of another person, the person on whose behalf the licensee is executing the contract shall be licensed under this section.

A corporation, limited liability company, partnership, or person doing business (h) under an assumed or designated trade name shall notify the Board in accordance with rules adopted by the Board if an individual licensee who is indicated in the license issued under this section ceases to be an officer, partner, owner, or employee of the corporation, limited liability company, partnership, or person doing business under the assumed or designated trade name. If the corporation, partnership, or person no longer has an officer, general partner, owner, or employee described in subdivision (a)(1), (b)(1), or (c)(1) of this section, the corporation, partnership, or person shall have 90 days from the date the officer, general partner, owner, or employee ceases the relationship with the corporation, partnership, or person to satisfy the requirements described in subdivision (a)(1), (b)(1), or (c)(1) of this section. After 90 days, if the corporation, partnership, or person does not have an officer, general partner, owner, or employee as described in subdivision (a)(1), (b)(1), or (c)(1) of this section, the license issued under this section is automatically suspended, and the corporation, partnership, or person shall

cease practicing irrigation construction or irrigation contracting. "§ 89G-6.2. Licensing of nonresidents.

Licensing. – Except as provided in this section, the Board may issue a license to a nonresident individual or a foreign entity that meets the requirements for licensure under this Chapter.

Information. – The Board, upon request, shall provide the Secretary of Revenue the (d) name, address, and tax identification number of every nonresident individual and foreign entity licensed by the Board. The information to be provided under this subsection shall be in a form required by the Secretary of Revenue.

Delinquents. - If the Secretary of Revenue determines that any nonresident individual or foreign entity licensed by the Board owes a delinquent income tax debt, the Secretary of Revenue may notify the Board of the nonresident individual and foreign entity and instruct the Board not to renew the nonresident individual or foreign entity's license. The Board shall not renew the license of a nonresident individual or foreign entity identified by the Secretary of Revenue unless the Board receives a written statement from the Secretary that (i) the debt has been paid or (ii) the debt is being paid pursuant to an installment agreement."

SECTION 4. G.S. 89G-9(b) reads as rewritten:

As a condition of license renewal, a-an individual licensee shall meet continuing "(b) education requirements set by the Board. Each licensee shall complete 10 continuing education units per year. Failure to obtain continuing education units shall result in the forfeiture of a license. The Board may suspend a licensee's license for 30 days for failure to obtain continuing education units required by this subsection. Upon payment of a reinstatement fee, the license shall be reinstated. Failure to request a reinstatement of the license and payment of the reinstatement fee shall result in the forfeiture of a license. Upon forfeiture, a person shall be required to submit a new application and retake the examination as provided in this Chapter."

SECTION 6. G.S. 89G-11 reads as rewritten:

"§ 89G-11. Disciplinary action.

The Board may deny, restrict, suspend, or revoke a license or refuse to issue or renew a license if a licensee or applicant:

- Employs the use of fraud, deceit, or misrepresentation in obtaining or (1) attempting to obtain a license or the renewal of a license.
- (2) Practices or attempts to practice irrigation construction or contracting by fraudulent misrepresentation.
- Commits an act of gross malpractice or incompetence as determined by the (3) Board.
