A BILL TO BE ENTITLED

2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO EXEMPT THE 3 CORE SOUND WATERFOWL MUSEUM AND HERITAGE CENTER FROM THE 4 FIRST IN FLIGHT BACKGROUND.

- 5 The General Assembly of North Carolina enacts: 6

SECTION 1. G.S. 20-63(b) reads as rewritten:

7 Every license plate must display the registration number assigned to the vehicle for "(b) 8 which it is issued, the name of the State of North Carolina, which may be abbreviated, and the 9 year number for which it is issued or the date of expiration. A plate issued for a commercial 10 vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word 11 "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for 12 vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted," 13 14 unless the plate is a special registration plate authorized in G.S. 20-79.4.

Except as otherwise provided in this subsection, a registration plate issued by the Division 15 16 for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less 17 shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" 18 printed at the top of the plate above all other letters and numerals. The background of the plate 19 shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying 20 slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be 21 22 approved by the Division and the State Highway Patrol for clarity and ease of identification.
