1 A BILL TO BE ENTITLED  
2 AN ACT TO ENSURE THAT THE RESOURCES OF THE PROGRAM EVALUATION  
3 DIVISION ARE UTILIZED EFFECTIVELY BY THE GENERAL ASSEMBLY, AS  
4 RECOMMENDED BY THE JOINT LEGISLATIVE PROGRAM EVALUATION  
5 OVERSIGHT COMMITTEE.

6 The General Assembly of North Carolina enacts:

7 SECTION 1. Chapter 120 of the General Statutes is amended by adding a new  
8 section to read:

9 "§ 120-36.17. Program Evaluation Division impact statement.

10 (a) Every bill and resolution introduced in the General Assembly proposing a study or  
11 evaluation by the Program Evaluation Division shall have attached to it at the time of its  
12 consideration by the General Assembly an impact statement prepared by the Division. The  
13 impact statement shall identify and estimate, to complete all studies and reports required by the  
14 bill or resolution, all of the following: (i) the number of personnel required; (ii) the total  
15 number of hours required; and (iii) the estimated costs.

16 (1) If, after review, the Division determines that no estimates are possible, the  
17 impact statement shall contain a statement to that effect, setting forth the  
18 reasons why no estimate can be given.

19 (2) The Division shall indicate whether the Division, based upon its current  
20 annual work plan, has adequate and sufficient resources to undertake the  
21 study or evaluation as part of the current annual work plan, and shall explain  
22 the basis for its determination.

23 (3) If the Division determines that it would not be able to undertake the study or  
24 evaluation as part of its current annual work plan, it shall indicate a time  
25 frame in which it believes the study or evaluation could be accomplished.

26 (b) The sponsor of each bill or resolution to which this section applies shall present a  
27 copy of the bill or resolution with the request for an impact statement to the Program  
28 Evaluation Division. Upon receipt of the request and the copy of the bill or resolution, the  
29 Program Evaluation Division shall prepare the impact statement as promptly as possible, but  
30 shall transmit it to the sponsor within two weeks after the request is made, unless the sponsor  
31 agrees to an extension of time. If the impact statement is not transmitted within two weeks, or  
32 by the end of any extension of time as provided under this subsection, then there shall be no  
33 impact statement required under this section.

34 (c) This impact statement shall be attached to the original of each proposed bill or  
35 resolution that is reported favorably by any committee of the General Assembly, but shall be

1 separate from the bill or resolution and shall be clearly designated as an impact statement. An  
2 impact statement attached to a bill or resolution pursuant to this subsection is not a part of the  
3 bill or resolution and is not an expression of legislative intent proposed by the bill or resolution.

4 (d) If a committee of the General Assembly reports favorably a proposed bill or  
5 resolution that directs the Program Evaluation Division to conduct a study or evaluation, the  
6 chair of the committee shall obtain from the Program Evaluation Division, and attach to the bill  
7 or resolution, an impact statement as provided in this section."

8 **SECTION 2.** G.S. 120-36.13(a) reads as rewritten:

9 **"§ 120-36.13. Work plan and requests for program evaluation.**

10 (a) Plan. – The Joint Legislative Program Evaluation Oversight Committee, in  
11 consultation with the Director of the Program Evaluation Division, must establish an annual  
12 work plan for the Division. The Division must adhere to this annual plan, unless the Joint  
13 Legislative Program Evaluation Oversight Committee changes the annual plan to add a new  
14 evaluation or remove a planned evaluation. Any enacted legislation that directs the Program  
15 Evaluation Division to conduct a study or an evaluation is included in the annual work plan by  
16 operation of ~~law-law~~; however, notwithstanding any other provision of law, if the enacted  
17 legislation did not have an impact statement, as provided in G.S. 120-36.17, completed prior to  
18 its consideration by the General Assembly, then the study or evaluation shall be included in the  
19 next annual work plan adopted by the Committee and one year shall be added to any required  
20 reporting dates included in the legislation, except that the impact statement is not required and  
21 the evaluation may be included in the current work plan if the impact statement was not  
22 provided pursuant to the time requirements in G.S. 120-36.17(b).

23 The annual work plan constitutes an information request and a drafting request made by the  
24 Committee cochairs to legislative employees under Article 17 of Chapter 120 of the General  
25 Statutes. Any document prepared by a legislative employee pursuant to the annual work plan  
26 becomes available to the public only as provided in G.S. 120-131. Any document prepared by  
27 an agency employee pursuant to a request under G.S. 120-131.1(a1) becomes available to the  
28 public only as provided in G.S. 120-131."

29 **SECTION 3.** This act is effective when it becomes law.
