SI Prescription I drug abuse au to curtail or r	Assembly of North Carolina enacts: ECTION 1.(a) There is created the Joint Legislative Study Commission of Drug Abuse by Students. The purpose of the Commission is to study prescription mong high school and college students in the State and to make recommendation educe the occurrences. ECTION 1.(b) The Commission shall consist of 15 members appointed a	
follows:		

- 11(1)Six members appointed by the Speaker of the House of Representatives to12include four members of the House of Representatives, one person who is a13licensed psychiatrist and one person who has experience as a drug abuse14counselor.
- 15(2)Six members appointed by the President Pro Tempore of the Senate to16include four members of the Senate, one person who is a licensed17psychologist and one member who is a high school guidance counselor.
  - (3) The President of The University of North Carolina or the President's designee.
    - (4) The President of the North Carolina Community College System or the President's designee.
      - (5) The Chairman of the State Board of Education or the Chairman's designee.

Vacancies on the Commission shall be filled by the appointing authority. A quorum
of the Commission shall consist of nine members.

The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall each appoint a cochair for the Commission. The Commission may meet at any time upon the joint call of the cochairs.

The Commission, while in the discharge of its official duties, may exercise all the powers provided under the provisions of G.S. 120-19 through G.S. 120-19.4, including the power to request all officers, agents, agencies, and departments of the State to provide any information, data, or documents within their possession, ascertainable from the records, or otherwise available to them, and the power to subpoena witnesses.

The Commission may contract for professional, clerical, or consultant services as
 provided by G.S. 120-32.02.

5	receive per diem, subsistence, and travel allowances at the rate established in G.S. 120-3.1,

3	<b>SECTION 1.(g)</b> Report. – The Commission shall submit a final report to the 2014		
)	Regular Session of the 2013 General Assembly. The report shall contain the Commission's		
)	findings, recommendations, and legislative proposals. The Commission shall terminate upon		
	filing its final report or upon the convening of the 2014 Regular Session, whichever is earlier.		
2	<b>SECTION 2.</b> This act is effective when it becomes law.
