Distribution of Fees. – The Special Registration Plate Account and the Collegiate (b) and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) of this section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund (CWMTF), which is established under G.S. 113A-253, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

SECTION 5. G.S. 20-81.12 reads as rewritten:

"§ 20-81.12. Collegiate insignia plates and certain other special plates.

(b148) North Carolina Paddle Festival. - The Division must receive 300 or more applications for a North Carolina Paddle Festival plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of North Carolina Paddle Festival plates to the Friends of the Hammocks and Bear Island, Inc.

(b149) Don't Tread on Me. – The applicable requirements of G.S. 20-79.3A must be met before a "Don't Tread on Me" plate may be developed. The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Don't Tread on Me" plates to middle school and high school career and technical education supplies, and middle school and high school career and technical education hardcopy and electronic textbooks, as provided through the career technical education program support funds allotment.

> **SECTION 6.** The Revisor of Statutes is authorized to alphabetize, number, and renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special registration plates are listed in alphabetical order and numbered accordingly.

> > **SECTION 7.** G.S. 20-84(b) is amended by adding a new subdivision to read:

"(20) A motor vehicle that is owned and operated by a congressionally chartered veterans service organization."

SECTION 8. This act becomes effective July 1, 2015.
