Short Title: Concealed Handgun Permit/Other Weapons. (Public)

Sponsors: Representatives Cleveland, Whitmire, and Faircloth (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE THAT A PERSON WHO HAS A CONCEALED HANDGUN  
3 PERMIT MAY ALSO CARRY A TASER, MACE, OR KNIFE SUBJECT TO THE  
4 SAME RESTRICTIONS THAT APPLY WHEN CARRYING A CONCEALED  
5 HANDGUN.  
6 The General Assembly of North Carolina enacts:  
7 **SECTION 1.** G.S. 14-269 is amended by adding a new subsection to read:  
8 "(a3) This prohibition does not apply if (i) the deadly weapon is a taser, mace, or a knife,  
9 provided the knife is not a spring-loaded projectile knife, a ballistic knife, or any weapon of  
10 similar character, (ii) the person has a concealed handgun permit issued in accordance with  
11 Article 54B of Chapter 14 of the General Statutes or considered valid under G.S. 14-415.24,  
12 and (iii) the person is carrying the concealed taser, mace, or knife in accordance with the scope  
13 of the concealed handgun permit as set out in G.S. 14-415.11(c) and G.S. 14-415.11(c4). The  
14 person is also subject to the same restrictions and prohibitions when carrying the taser, mace, or  
15 knife that apply when the person is carrying a concealed handgun. This subsection shall not be  
16 construed to allow a person to carry a spring-loaded projectile knife, a ballistic knife, or any  
17 weapon of similar character which is unlawful under G.S. 14-269.6."  
18 **SECTION 2.** G.S. 14-415.11 is amended by adding a new subsection to read:  
19 "(c4) Any person who has a concealed handgun permit may carry a taser, mace, or knife,  
20 provided the knife is not a spring-loaded projectile knife, a ballistic knife, or any weapon of  
21 similar character, subject to the same restrictions and prohibitions that apply to a person when  
22 the person is carrying a concealed handgun. Except as provided in G.S. 14-415.27, a permit  
23 does not authorize a person to carry a taser, mace, or knife in any of the areas or locations listed  
24 in subsection (c) of this section. This subsection shall not be construed to allow a person to  
25 carry a spring-loaded projectile knife, a ballistic knife, or any weapon of similar character  
26 which is unlawful under G.S. 14-269.6."  
27 **SECTION 3.** This act becomes effective December 1, 2015.
