9	may be condemned or acquired by a unit of local government <u>inside or outside</u>		
10	the county.

12	general law or local act conferring the power of eminent domain, before final judgment may be		
13	entered in any action of condemnation initiated by a county, city or town, special district, or		
14	other unit of local government which is located wholly or primarily outside another county,		
15	whereby the condemnor seeks to acquire property located in the other county, the condemnor		
16	shall furnish proof that the county board of commissioners of the county where the land is		
17	located has consented to the taking.

- 12 **SECTION 2.** This act becomes effective July 1, 2015, and applies to 13 condemnations, exchanges, purchases, or leases on or after that date.
