

12		(1) Duties. – All activities on school property.	
13		(2) Employee. – Has the same meaning as G.S. 14-33(c)(6)b.1. and 2	<u>2.</u>
14		(3) School property. – Any school building, bus, school campu	us, grounds,
15		recreational area, athletic field, or other property owned, used,	or operated
16		by any board of education or school board of trustees, or direct	ctors for the
17		administration of any primary or secondary school.	
18		(4) Student. – A person enrolled in a public school, a charter school	
19		under G.S. 115C-218.5, or a nonpublic school which has file

22	<u>(b)</u>	Offense Unless the conduct is covered under some other provis	
23		greater punishment, a student who assaults a school employee is guilty	of a felony

25		(1) The student is 16 years of age or older.	
26		(2) The student assaults the school employee when the employee is	
27		or attempting to discharge his or her duties as an employee, or	
28		assaults the school employee as a result of the discharge or	r attempt to
29		discharge that individual's duties as a school employee.	
30		(3) The assault occurs on school property.

34		SECTION 2. This act becomes effective December 1, 2015, and	1 applies to
