2 AN ACT TO MAKE TECHNICAL CORRECTIONS TO THE GENERAL STATUTES, AS  
3 RECOMMENDED BY THE GENERAL STATUTES COMMISSION, AND TO MAKE  
4 ADDITIONAL TECHNICAL AND OTHER AMENDMENTS TO THE GENERAL  
5 STATUTES.

6 The General Assembly of North Carolina enacts:

8 **PART I. TECHNICAL CORRECTIONS RECOMMENDED BY THE GENERAL**  
9 **STATUTES COMMISSION**

10 **SECTION 1.** G.S. 1-117 reads as rewritten:

11 "**§ 1-117. Cross-index of lis pendens.**

12 Every notice of pending litigation filed under this Article shall be cross-indexed by the clerk of  
13 the superior court in a record, called the "Record of Lis Pendens," to be kept by ~~him pursuant to~~  
14 ~~G.S. 2-42(6)-the clerk under G.S. 7A-109."~~

15 **SECTION 1.1.** G.S. 14-118.6(b1) reads as rewritten:

16 "(b1) When a lien or encumbrance is presented to a clerk of superior court for filing and the  
17 clerk of court has a reasonable suspicion that the lien or encumbrance is false as described in  
18 subsection (a) of this section, the clerk of court may refuse to file the lien or encumbrance. Neither  
19 the clerk of court nor the clerk's staff shall be liable for filing or the refusal to file a lien or  
20 encumbrance under this subsection. The clerk of superior court shall not file, index, or docket the  
21 document against the property of a public officer or public employee until that document is  
22 approved by any judge of the judicial district having subject matter jurisdiction for filing by the  
23 ~~clerk of superior court by any judge of the judicial district having subject matter jurisdiction.~~  
24 court. If the judge determines that the filing is not false, the clerk shall index the claim of lien. A  
25 lien or encumbrance filed upon order of the court under this subsection shall have a priority  
26 interest as of the date and time of indexing by the clerk of superior court. If the court finds that  
27 there is no statutory or contractual basis for the proposed filing, the court shall enter an order that  
28 the proposed filing is null and void as a matter of law, and that it shall not be filed or indexed. The  
29 clerk of superior court shall serve the order and return the original denied filing to the person or  
30 entity that presented it. The person or entity shall have 30 days from the entry of the order to  
31 appeal the order. If the order is not appealed within the applicable time period, the clerk may  
32 destroy the filing."

33 **SECTION 1.2.** G.S. 14-159.3(a1) reads as rewritten:

1 "(a1) A landowner who gives a person written consent to operate an all-terrain vehicle on his  
2 ~~or her~~ the landowner's property owes the person the same duty of care that ~~he or she~~ the landowner  
3 owes a trespasser."

4 **SECTION 2.** G.S. 14-208.6 reads as rewritten:

5 **"§ 14-208.6. Definitions.**

6 The following definitions apply in this Article:

7 ...

8 (5) "Sexually violent offense" means a violation of former G.S. 14-27.6 (attempted  
9 rape or sexual offense), G.S. 14-27.21 (first-degree forcible rape),  
10 G.S. 14-27.22 (second-degree forcible rape), G.S. 14-27.23 (statutory rape of a  
11 child by an adult), G.S. 14-27.24 (first-degree statutory rape), G.S. 14-27.25(a)  
12 (statutory rape of a person who is 15 years of age or younger and where the  
13 defendant is at least six years older), G.S. 14-27.26 (first-degree forcible sexual  
14 offense), G.S. 14-27.27 (second-degree forcible sexual offense), G.S. 14-27.28  
15 (statutory sexual offense with a child by an adult), G.S. 14-27.29 (first-degree  
16 statutory sexual offense), G.S. 14-27.30(a) (statutory sexual offense with a  
17 person who is 15 years of age or younger and where the defendant is at least six  
18 years older), G.S. 14-27.31 (sexual activity by a substitute parent or custodian),  
19 G.S. 14-27.32 (sexual activity with a student), G.S. 14-27.33 (sexual battery),  
20 G.S. 14-43.11 (human trafficking) if (i) the offense is committed against a  
21 minor who is less than 18 years of age or (ii) the offense is committed against  
22 any person with the intent that they be held in sexual servitude, G.S. 14-43.13  
23 (subjecting or maintaining a person for sexual servitude), G.S. 14-178 (incest  
24 between near relatives), G.S. 14-190.6 (employing or permitting minor to assist  
25 in offenses against public morality and decency), G.S. 14-190.9(a1) (felonious  
26 indecent exposure), G.S. 14-190.16 (first degree sexual exploitation of a  
27 minor), G.S. 14-190.17 (second degree sexual exploitation of a minor),  
28 G.S. 14-190.17A (third degree sexual exploitation of a minor), G.S. 14-202.1  
29 (taking indecent liberties with children), G.S. 14-202.3 (Solicitation of child by  
30 computer or certain other electronic devices to commit an unlawful sex act),  
31 G.S. 14-202.4(a) (taking indecent liberties with a student), G.S. 14-205.2(c) or  
32 (d) (patronizing a prostitute who is a minor or a mentally disabled person),  
33 G.S. 14-205.3(b) (promoting prostitution of a minor or a mentally disabled  
34 person), G.S. 14-318.4(a1) (parent or caretaker commit or permit act of  
35 prostitution with or by a juvenile), or G.S. 14-318.4(a2) (commission or  
36 allowing of sexual act upon a juvenile by parent or guardian). The term also  
37 includes the following: a solicitation or conspiracy to commit any of these  
38 offenses; aiding and abetting any of these offenses.

39 ...."

40 **SECTION 2.1.** G.S. 20-45 reads as rewritten:

41 **"§ 20-45. Seizure of documents and plates.**

42 (a) The Division is ~~hereby~~ authorized to take possession of any certificate of title,  
43 registration card, permit, license, or registration plate issued by it upon expiration, revocation,  
44 cancellation, or suspension thereof, or which is fictitious, or which has been unlawfully or  
45 erroneously issued, or which has been unlawfully used.

46 (b) The Division may give notice to the owner, licensee or lessee of its authority to take  
47 possession of any certificate of title, registration card, permit, license, or registration plate issued  
48 by it and require that person to surrender it to the Commissioner or ~~his~~ the Commissioner's  
49 officers or agents. Any person who fails to surrender the certificate of title, registration card,  
50 permit, license, or registration plate or any duplicate thereof, upon personal service of notice or

1 within 10 days after receipt of notice by mail as provided in G.S. 20-48, shall be guilty of a Class  
2 misdemeanor.

3 (c) Any sworn law enforcement officer with jurisdiction, including a member of the State  
4 Highway Patrol, is authorized to seize the certificate of title, registration card, permit, license, or  
5 registration plate, if the officer has electronic or other notification from the Division that the item  
6 has been revoked or cancelled, or otherwise has probable cause to believe that the item has been  
7 revoked or cancelled under any law or statute, including ~~G.S. 20-309(e)~~. G.S. 20-311. If a criminal  
8 proceeding relating to a certificate of title, registration card, permit, or license is pending, the law  
9 enforcement officer in possession of that item shall retain the item pending the entry of a final  
10 judgment by a court with jurisdiction. If there is no criminal proceeding pending, the law  
11 enforcement officer shall deliver the item to the Division.

12 (d) Any law enforcement officer who seizes a registration plate pursuant to this section  
13 shall report the seizure to the Division within 48 hours of the seizure and shall return the  
14 registration plate, but not a fictitious registration plate, to the Division within 10 business days of  
15 the seizure."

16 **SECTION 3.** The catch line of G.S. 20-171.24 reads as rewritten:

17 "**§ 20-171.24. Motorized all-terrain vehicle use by municipal and county employees of listed**  
18 **municipalities and counties permitted on certain highways.**"

19 **SECTION 3.1.** G.S. 24-10.1(a) reads as rewritten:

20 "(a) Subject to the limitations contained in subsection (b) of this section, any lender may  
21 charge a party to a loan or extension of credit governed by the provisions of ~~G.S. 24-1.1, 24-1.2,~~  
22 G.S. 24-1.1 or G.S. 24-1.1A a late payment charge as agreed upon by the parties in the loan  
23 contract."

24 **SECTION 4.** G.S. 28A-2-4 reads as rewritten:

25 "**§ 28A-2-4. Subject matter jurisdiction of the clerk of superior court in estate proceedings.**

26 (a) The clerks of superior court of this State, as ex officio judges of probate, shall have  
27 original jurisdiction of estate proceedings. Except as provided in subdivision (4) of this subsection,  
28 the jurisdiction of the clerk of superior court is exclusive. Estate proceedings include, but are not  
29 limited to, the following:

- 30 (1) Probate of wills.
- 31 (2) Granting and revoking of letters testamentary and letters of administration, or  
32 other proper letters of authority for the administration of estates.
- 33 (3) Determination of the elective share for a surviving spouse as provided in  
34 G.S. 30-3.
- 35 (4) Proceedings to ascertain heirs or devisees, to approve settlement agreements  
36 pursuant to G.S. 28A-2-10, to determine questions of construction of wills, to  
37 determine priority among creditors, to determine whether a person is in  
38 possession of property belonging to an estate, to order the recovery of property  
39 of the estate in possession of third parties, and to determine the existence or  
40 nonexistence of any immunity, power, privilege, duty, or right. Any party or the  
41 clerk of superior court may file a notice of transfer of a proceeding pursuant to  
42 this subdivision to the Superior Court Division of the General Court of Justice  
43 as provided in G.S. 28A-2-6(h). In the absence of a transfer to superior court,  
44 Article 26 of Chapter 1 of the General Statutes shall apply to ~~a trust~~ an estate  
45 proceeding pending before the clerk of superior court to the extent consistent  
46 with this Article.

47 (b) Nothing in this section shall affect the right of a person to file an action in the Superior  
48 Court Division of the General Court of Justice for declaratory relief under Article 26 of Chapter 1  
49 of the General Statutes. In the event that either the petitioner or the respondent in an estate  
50 proceeding requests declaratory relief under Article 26 of Chapter 1 of the General Statutes, either  
51 party may move for a transfer of the proceeding to the Superior Court Division of the General

1 Court of Justice as provided in Article 21 of Chapter 7A of the General Statutes. In the absence of  
 2 a removal to superior court, Article 26 of Chapter 1 of the General Statutes shall apply to an estate  
 3 proceeding to the extent consistent with this Article.

4 (c) Without otherwise limiting the jurisdiction of the Superior Court Division of the  
 5 General Court of Justice, the clerk of superior court shall not have jurisdiction under subsection (a)  
 6 or ~~(e)-(b)~~ of this section or G.S. 28A-2-5 of the following:

- 7 (1) Actions by or against creditors or debtors of an estate, except as provided in  
 8 Article 19 of this Chapter.
- 9 (2) Actions involving claims for monetary damages, including claims for breach of  
 10 fiduciary duty, fraud, and negligence.
- 11 (3) Caveats, except as provided under G.S. 31-36.
- 12 (4) Proceeding to determine proper county of venue as provided in G.S. 28A-3-2.
- 13 (5) Recovery of property transferred or conveyed by a decedent with intent to  
 14 hinder, delay, or defraud creditors, pursuant to G.S. 28A-15-10(b)."

15 **SECTION 5.** Reserved.

16 **SECTION 6.** G.S. 28A-19-5(b) reads as rewritten:

17 "(b) With respect to a contingent or unliquidated claim rejected by a personal representative  
 18 pursuant to G.S. 28A-19-16, the claimant may, within the three-month period prescribed by  
 19 G.S. 28A-19-16, file a petition for an order of the clerk of superior court in accordance with  
 20 subsection (a) of this section, provided that nothing in this section shall require the clerk of  
 21 superior court to hear and determine the validity of, priority of, or amount of a contingent or  
 22 unliquidated claim that has not yet become absolute."

23 **SECTION 7.** G.S. 31B-1(a) reads as rewritten:

24 "(a) A person who succeeds to a property interest as:

- 25 ...
- 26 (8) ~~Appointee~~ Appointee, permissible appointee, or taker in default under a power  
 27 of appointment exercised by a testamentary instrument or a nontestamentary  
 28 instrument;

29 ...

30 may renounce at anytime, in whole or in part, the right of succession to any property or interest  
 31 therein, including a future interest, by filing a written instrument under the provisions of this  
 32 Chapter. A renunciation may be of a fractional share or any limited interest or estate. The  
 33 renunciation shall be deemed to include the entire interest of the person whose property or interest  
 34 is being renounced unless otherwise specifically limited. A person may renounce any interest in or  
 35 power over property, including a power of appointment, even if its creator imposed a spendthrift  
 36 provision or similar restriction on transfer or a restriction or limitation on the right to renounce.  
 37 Notwithstanding the foregoing, there shall be no right of partial renunciation if the instrument  
 38 creating the interest expressly so provides."

39 **SECTION 7.1.** G.S. 36C-8-816.1 reads as rewritten:

40 **"§ 36C-8-816.1. Trustee's special power to appoint to a second trust.**

41 (a) For purposes of this section, the following definitions apply:

- 42 (1) Current beneficiary. – A person who is a permissible distributee of trust income  
 43 or principal.
- 44 (2) Original trust. – A trust established under an irrevocable trust instrument  
 45 pursuant to the terms of which a trustee has a discretionary power to distribute  
 46 principal or income of the trust to or for the benefit of one or more current  
 47 beneficiaries of the trust.
- 48 (3) Second trust. – A trust established under an irrevocable trust instrument, the  
 49 current beneficiaries of which are one or more of the current beneficiaries of the  
 50 original trust. The second trust may be a trust created under the same trust  
 51 instrument as the original trust or under a different trust instrument.

1 (b) A trustee of an original trust may, without authorization by the court, exercise the  
2 discretionary power to distribute principal or income to or for the benefit of one or more current  
3 beneficiaries of the original trust by appointing all or part of the principal or income of the original  
4 trust subject to the power in favor of a trustee of a second trust. The trustee of the original trust  
5 may exercise this power whether or not there is a current need to distribute principal or income  
6 under any standard provided in the terms of the original trust. The trustee's special power to  
7 appoint trust principal or income in further trust under this section includes the power to create the  
8 second trust. The second trust may have a duration that is longer than the duration of the first trust.

9 (c) The terms of the second trust shall be subject to all of the following:

- 10 (1) The beneficiaries of the second trust may include only beneficiaries of the  
11 original trust.
- 12 (2) A beneficiary who has only a future beneficial interest, vested or contingent, in  
13 the original trust cannot have the future beneficial interest accelerated to a  
14 present interest in the second trust.
- 15 (3) The terms of the second trust may not reduce any fixed income, annuity, or  
16 unitrust interest of a beneficiary in the assets of the original trust if that interest  
17 has come into effect with respect to the beneficiary.
- 18 (4) If any contribution to the original trust qualified for a marital or charitable  
19 deduction for federal income, gift, or estate tax purposes under the Internal  
20 Revenue Code, then the second trust shall not contain any provision that, if  
21 included in the original trust, would have prevented the original trust from  
22 qualifying for the deduction or that would have reduced the amount of the  
23 deduction.
- 24 (5) If contributions to the original trust have been excluded from the gift tax by the  
25 application of section 2503(b) and section 2503(c) of the Internal Revenue  
26 Code, then the second trust shall provide that the beneficiary's remainder  
27 interest in the contributions shall vest and become distributable no later than the  
28 date upon which the interest would have vested and become distributable under  
29 the terms of the original trust.
- 30 (6) If any beneficiary of the original trust has a power of withdrawal over trust  
31 property, then either:
  - 32 a. The terms of the second trust must provide a power of withdrawal in the  
33 second trust identical to the power of withdrawal in the original trust; or
  - 34 b. Sufficient trust property must remain in the original trust to satisfy the  
35 outstanding power of withdrawal.
- 36 (7) If a trustee of an original trust exercises a power to distribute principal or  
37 income that is subject to an ascertainable standard by appointing property to a  
38 second trust, then the power to distribute income or principal in the second trust  
39 must be subject to the same ascertainable standard as in the original trust and  
40 must be exercisable in favor of the same current beneficiaries to whom such  
41 distribution could be made in the original trust.
- 42 (8) The second trust may confer a power of appointment upon a beneficiary of the  
43 original trust to whom or for the benefit of whom the trustee has the power to  
44 distribute principal or income of the original trust. The permissible appointees  
45 of the power of appointment conferred upon a beneficiary may include persons  
46 who are not beneficiaries of the original or second trust. The power of  
47 appointment conferred upon a beneficiary shall be subject to the provisions of  
48 G.S. 41-23 specifying the permissible period allowed for the suspension of the  
49 power of alienation of the original trust and the time from which that  
50 permissible period is computed.

- 1           (9)    The terms of the second trust shall not contain any provisions that would  
2           jeopardize (i) the qualification of a transfer as a direct skip under section  
3           2642(c) of the ~~Internal Revenue~~ Internal Revenue Code, (ii) if the first trust  
4           owns subchapter S Corporation stock, the election to treat a corporation as a  
5           subchapter S Corporation under section 1362 of the Internal Revenue Code,  
6           (iii) if the first trust owns an interest in property subject to the minimum  
7           distribution rules of section 401(a)(9) of the Internal Revenue Code, a favorable  
8           distribution period by shortening the minimum distribution period, or (iv) any  
9           other specific tax benefit for which ~~a contribution originally the first trust was~~  
10          clearly designed to qualify and for which the first trust qualified or would have  
11          qualified for income, gift, estate, or generation skipping transfer tax purposes,  
12          but for the enactment of this section. In this subdivision, "tax benefit" means a  
13          federal or State tax deduction, exemption, exclusion, or other benefit not  
14          otherwise listed in this section, except for the benefit from having the settlor  
15          considered the owner under sections 671 through 679 of the Internal Revenue  
16          Code. Subject to clause (ii) above, the second trust may be a trust as to which  
17          the settlor is not considered the owner under sections 671 through 679 of the  
18          Internal Revenue Code even if the settlor is considered the owner of the first  
19          trust, and the second trust may be a trust as to which the settlor of the first trust  
20          is considered the owner under sections 671 through 679 of the Internal Revenue  
21          Code, even if the settlor is not considered the owner of the first trust.
- 22          (10) Notwithstanding any other provision of this section, but subject to the  
23          limitations of subdivisions (1), (2), (4), (5), and (9) of this subsection, a trustee  
24          may exercise the power to appoint principal and income under subsection (b) of  
25          this section with respect to a disabled beneficiary's interest in the original trust  
26          to a second trust that is a supplemental needs trust that does not have (i) an  
27          ascertainable standard (or has a different ascertainable standard); (ii) a fixed  
28          income, annuity, or unitrust interest in the assets of the original trust; or (iii) a  
29          right of withdrawal, if the trustee determines that it would be in the best interest  
30          of the disabled beneficiary. For purposes of this subsection, the following  
31          apply:
- 32               a.    A "supplemental needs trust" means a trust that is a discretionary trust  
33               under G.S. 36C-5-504 and relative to the original trust contains either  
34               lesser or greater restrictions on the trustee's power to distribute income  
35               or principal, and which the trustee believes would, if implemented,  
36               allow the disabled beneficiary to receive greater governmental benefits  
37               than the disabled beneficiary would receive if the power to appoint  
38               principal and income had not been exercised.
- 39               b.    "Governmental benefits" means medical assistance, financial aid, or  
40               services from any local, State, or federal agency or department.
- 41               c.    A "disabled beneficiary" means a current beneficiary of the original  
42               trust who the trustee determines has a condition that substantially  
43               impairs the beneficiary's ability to provide for his or her own support,  
44               care, or custody whether or not the beneficiary has been adjudicated a  
45               "disabled person" by any government agency or department.
- 46               d.    The second supplemental needs trust shall not be liable to pay or  
47               reimburse the State or any government or public agency for medical  
48               assistance, financial aid, or services provided to the disabled beneficiary  
49               except as provided in the second supplemental needs trust.
- 50          (d)    A trustee may not exercise the power to appoint principal or income under subsection  
51          (b) of this section if the trustee is a beneficiary of the original trust, but the remaining cotrustee or

1 a majority of the remaining cotrustees may act for the trust. If all the trustees are beneficiaries of  
2 the original trust, then the court may appoint a special fiduciary with authority to exercise the  
3 power to appoint principal or income under subsection (b) of this section.

4 (e) The exercise of the power to appoint principal or income under subsection (b) of this  
5 section:

6 (1) Shall be considered the exercise of a power of appointment, other than a power  
7 to appoint to the trustee, the trustee's creditors, the trustee's estate, or the  
8 creditors of the trustee's estate; and

9 (2) Shall be subject to the provisions of G.S. 41-23 specifying the permissible  
10 period allowed for the suspension of the power of alienation of the original trust  
11 and the time from which that permissible period is computed; and

12 (3) Is not prohibited by a spendthrift provision or by a provision in the original  
13 trust instrument that prohibits amendment or revocation of the trust.

14 (f) To effect the exercise of the power to appoint principal or income under subsection (b)  
15 of this section, all of the following shall apply:

16 (1) The exercise of the power to appoint shall be made by an instrument in writing,  
17 signed and acknowledged by the trustee, setting forth the manner of the  
18 exercise of the power, including the terms of the second trust, and the effective  
19 date of the exercise of the power. The instrument shall be filed with the records  
20 of the original trust.

21 (2) The trustee shall give written notice to all qualified beneficiaries of the original  
22 trust, at least 60 days prior to the effective date of the exercise of the power to  
23 appoint, of the trustee's intention to exercise the power. The notice shall include  
24 a copy of the instrument described in subdivision (1) of this subsection.

25 (3) If all qualified beneficiaries waive the notice period by a signed written  
26 instrument delivered to the trustee, the trustee's power to appoint principal or  
27 income shall be exercisable after notice is waived by all qualified beneficiaries,  
28 notwithstanding the effective date of the exercise of the power.

29 (4) The trustee's notice under this subsection shall not limit the right of any  
30 beneficiary to object to the exercise of the trustee's power to appoint and bring  
31 an action for breach of trust seeking appropriate relief as provided by  
32 G.S. 36C-10-1001.

33 (g) Nothing in this section shall be construed to create or imply a duty of the trustee to  
34 exercise the power to distribute principal or income, and no inference of impropriety shall be made  
35 as a result of a trustee not exercising the power to appoint principal or income conferred under  
36 subsection (b) of this section. Nothing in this section shall be construed to abridge the right of any  
37 trustee who has a power to appoint property in further trust that arises under the terms of the  
38 original trust or under any other section of this Chapter or under another provision of law or under  
39 common law.

40 (h) A trustee or beneficiary may commence a proceeding to approve or disapprove a  
41 proposed exercise of the trustee's special power to appoint to a second trust pursuant to subsection  
42 (b) of this section."

43 **SECTION 7.2.(a)** G.S. 39-33 and G.S. 39-34 are repealed.

44 **SECTION 7.2.(b)** G.S. 39-35 is recodified as G.S. 31D-5-505.

45 **SECTION 7.2.(c)** G.S. 39-36 is recodified as G.S. 31D-4-403.1.

46 **SECTION 7.3.** G.S. 42A-17(a) reads as rewritten:

47 "(a) A vacation rental agreement shall identify the name and address of the ~~bank or savings~~  
48 ~~and loan association~~ federally insured depository institution in which the tenant's security deposit  
49 and other advance payments are held in a trust account, and the landlord and real estate broker  
50 shall provide the tenant with an accounting of such deposit and payments if the tenant makes a  
51 reasonable request for an accounting prior to the tenant's occupancy of the property."

1           **SECTION 7.4.** G.S. 97-25(f) reads as rewritten:

2           "(f) In claims subject to G.S. 97-18(b) and (d), a party may file a motion as set forth in this  
3 subsection regarding a request for medical compensation or a dispute involving medical issues.  
4 The nonmoving party shall have the right to contest the motion. Motions and responses shall be  
5 submitted contemporaneously via electronic ~~mail-means~~ to the Commission and to the opposing  
6 party or the opposing party's ~~attorney[, as follows]:~~attorney, as follows:

7           (1) A party may file a motion with the Executive Secretary for an administrative  
8 ruling regarding a request for medical compensation or a dispute involving  
9 medical issues. The motion shall be decided administratively pursuant to rules  
10 governing motions practices in contested cases. The Commission shall decide  
11 the motion within 30 days of the filing of the motion unless an extension of  
12 time to respond to the motion has been granted for good cause shown. Either

17 the motion for reconsideration. Within five days of the filing of a request for an  
18 expedited formal hearing pursuant to G.S. 97-84 and subdivision (2) of this  
19 subsection to appeal the decision of the Executive Secretary, the Commission  
20 shall assign a Deputy Commissioner to conduct the formal hearing. The  
21 decision shall not be stayed during the pendency of an appeal pursuant to  
22 G.S. 97-84 and subdivision (2) of this subsection except under those  
23 circumstances set out in subdivision (4) of this subsection. A motion to stay  
24 shall be filed with the Deputy Commissioner scheduled to conduct the formal  
25 hearing pursuant to G.S. 97-84. Either party may appeal the decision of the  
26 Deputy Commissioner pursuant to G.S. 97-84 to the Full Commission pursuant  
27 to G.S. 97-85. The decision of the Deputy Commissioner shall not be stayed  
28 during the pendency of an appeal except under those circumstances set out in  
29 subdivision (4) of this subsection. A motion to stay the decision of the Deputy  
30 Commissioner pursuant to G.S. 97-84 shall be directed to the Chair of the  
31 Commission. The Full Commission shall render a decision on the appeal of the  
32 Deputy Commissioner's decision on the motion within 60 days of the filing of  
33 the notice of appeal.

## 34 **PART II. ADDITIONAL TECHNICAL AND OTHER AMENDMENTS**

35 **SECTION 15.** G.S. 7A-45.1(a10) reads as rewritten:

36 "(a10) Except for the judgeships abolished pursuant to subsection (a8) of this section, upon  
37 the retirement, resignation, removal from office, death, or expiration of the term of any special  
38 superior court judge on or after September 1, 2014, each judgeship shall be filled for a full  
39 five-year term beginning upon the judge's taking office according to the following procedure  
40 prescribed by the General Assembly pursuant to Article IV, Section 9(1) of the North Carolina  
41 Constitution. As each judgeship becomes vacant or the term expires, the Governor shall submit the  
42 name of a nominee for that judgeship to the General Assembly for confirmation by ratified joint  
43 resolution. Upon each such confirmation, the Governor shall appoint the confirmed nominee to  
44 that judgeship. The term of the special superior court judge commencing on March 1, 2011, shall  
45 expire on the earlier of (i) the date on which the office shall become vacant through retirement,

23 which their claims depend do not have a common origin or are not identical but are adverse to and  
24 independent of one another, or that the plaintiff avers that he is not liable in whole or in part to any  
25 or all of the claimants. A defendant exposed to similar liability may obtain such interpleader by  
26 way of crossclaim or counterclaim. The provisions of this rule supplement and do not in any way  
27 limit the joinder of parties permitted in Rule 20.

10 **"§ 116-30.3. Reversions.**

11 (a) Of the General Fund current operations appropriations credit balance remaining at the  
12 end of each fiscal year in each of the budget codes listed in this subsection, any amount of the  
13 General Fund appropriation for that budget code for that fiscal year (i) may be carried forward to  
14 the next fiscal year in that budget code, (ii) is appropriated in that budget code, and (iii) may be  
15 used for any of the purposes set out in subsection (f) of this section. However, the amount carried  
16 forward in each budget code under this subsection shall not exceed ~~two and one-half percent~~  
17 ~~(2.5%)~~ five percent (5%) of the General Fund appropriation in that budget code. The Director of  
18 the Budget, under the authority set forth in G.S. 143C-6-2, shall establish the General Fund current  
19 operations credit balance remaining in each budget code.
