## A BILL TO BE ENTITLED

## AN ACT MANDATING THAT THE DIVISION OF MOTOR VEHICLES OFFER VOTER REGISTRATION WHEN A PERSON SEEKS ISSUANCE OR RENEWAL OF A DRIVERS LICENSE OR VALID NORTH CAROLINA IDENTIFICATION CARD.

**SECTION 1.** G.S. 163-82.19 reads as rewritten:

"§ 163-82.19. Voter registration at drivers license offices; coordination on data interface.

8 Voter Registration at Drivers License Offices. - The Division of Motor Vehicles shall, 9 pursuant to the rules adopted by the State Board of Elections, modify its forms so that any eligible 10 person who applies for original issuance, renewal or correction of a drivers license, or special identification card issued under G.S. 20-37.7 may, shall, on a part of the form, complete an 11 12 application to register to vote, or to update the voter's registration if the voter has changed his or her address or moved from one precinct to another or from one county to another. The person 13 taking the application shall ask if the applicant is a citizen of the United States. If the applicant 14 states that the applicant is not a citizen of the United States, or declines to answer the question, the 15 person taking the application shall inform the applicant that it is a felony for a person who is not a 16 17 citizen of the United States to apply to register to vote. Any person who willfully and knowingly and with fraudulent intent gives false information on the application is guilty of a Class I felony. 18 19 The application shall state in clear language the penalty for violation of this section. The necessary forms shall be prescribed by the State Board of Elections. The form must ask for the previous 20 voter registration address of the voter, if any. If a previous address is listed, and it is not in the 21 county of residence of the applicant, the appropriate county board of elections shall treat the 22 23 application as an authorization to cancel the previous registration and also process it as such under the procedures of G.S. 163-82.9. If a previous address is listed and that address is in the county 24 25 where the voter applies to register, the application shall be processed as if it had been submitted 26 under G.S. 163-82.9. In addition to providing the information requested in this subsection and listed under G.S. 163-82.4, an applicant shall provide a notation on the form attesting that the 27 applicant meets all the voter eligibility requirements, including United States citizenship, and 28 29 whether the applicant affirmatively declined to become a registered voter while conducting business at the drivers license office. 30

Registration shall become effective as provided in G.S. 163-82.7. Applications to register to vote accepted at a drivers license office under this section until the deadline established in G.S. 163-82.6(c)(2) shall be treated as timely made for an election, and no person who completes an application at that drivers license office shall be denied the vote in that election for failure to apply earlier than that deadline.

| 13 | the Department of Transportation to verify the accuracy of the information provided on                  |
| 14 | applications for voter registration, whether the applications were received at drivers license offices  |
| 15 | or elsewhere. The Department of Transportation and the State Board shall implement the                  |
| 16 | provisions of this subsection so as to comply with section 303 of the Help America Vote Act of          |
| 17 | 2002. The Department of Transportation shall enter into an agreement with the Commissioner of           |
| 18 | Social Security so as to comply with section 303 of the Help America Vote Act of 2002."                 |
| 19 | SECTION 2. There is appropriated from the General Fund to the State Board of                            |
| 20 | Elections the sum of two hundred fifty thousand dollars (\$250,000) for the 2016-2017 fiscal year       |
| 21 | for the purpose of implementing the requirements for automatic voter registration under this act.       |
| 22 | <b>SECTION 3.</b> Section 1 of this act becomes effective January 1, 2017, and applies to               |
| 23 | elections held on or after that date. The remainder of this act becomes effective July 1, 2016.         |
