1	A BILL TO BE ENTITLED
2	AN ACT AMENDING THE CHARTER OF THE TOWN OF CHADBOURN TO AUTHORIZE
3	THE TOWN COUNCIL TO APPOINT THE TOWN CLERK.
4	The General Assembly of North Carolina enacts:
5	SECTION 1. Article IV of the Charter of the Town of Chadbourn, being Chapter 895
6	of the 1989 Session Laws, as amended by S.L. 2007-271, reads as rewritten:
7	"ARTICLE IV. ORGANIZATION AND ADMINISTRATION
8	"Sec. 4.1. Form of Government. The Town shall operate under the council-manager form of
9	government, in accordance with Part 2 of Article 7 of Chapter 160A of the General Statutes.
10	"Sec. 4.2. Town Manager. The Council shall appoint a Town Manager who shall be
11	responsible for the administration of all departments of the Town government. The Town Manager
12	shall have all the powers and duties conferred by general law, except as expressly limited by the
13	provisions of this Charter, and the additional powers and duties conferred by the Council, so far as
14	authorized by general law.
15	"Sec. 4.3. Town Clerk. The Town Manager Council shall appoint a Town Clerk to keep a
16	journal of the proceedings of the Council, to maintain official records and documents; to give
17	notice of meetings; and to perform such other duties required by law or as the Council may direct.
18	"Sec. 4.4. Tax Collector. The Town Manager shall appoint a Tax Collector pursuant to
19	G.S. 105-349 to collect all taxes owed to the Town, subject to general law, this Charter and Town
20	ordinances.
21	"Sec. 4.5. Town Attorney. The Council shall appoint a Town Attorney licensed to practice law
22	in North Carolina. It shall be the duty of the Town Attorney to represent the Town, advise Town
23	officials and perform other duties required by law or as the Council may direct.
24	"Sec. 4.6. Fire Chief. The Council shall appoint a Fire Chief qualified to perform the duties of
25 26	chief of the Chadbourn Volunteer Fire Department and Rescue Squad.
20 27	"Sec. 4.7. Other Administrative Officers and Employees. The Council may authorize other positions to be filled by appointment by the Town Manager, and may organize the Town
27	government as deemed appropriate, subject to the requirements of general law."
28	<b>SECTION 2.</b> This act is effective when it becomes law.
