1                   **A BILL TO BE ENTITLED**

2                   **AN ACT TO ENACT THE HURRICANE FLORENCE EMERGENCY RESPONSE ACT.**

3                   The General Assembly of North Carolina enacts:

5                   **PART I. TITLE OF ACT**

6                   **SECTION 1.1.** This act shall be known as "The Hurricane Florence Emergency  
7                   Response Act."

9                   **PART II. LEGISLATIVE FINDINGS**

10

11                  **DAMAGE CAUSED BY HURRICANE FLORENCE**

12                  **SECTION 2.1.(a)** The General Assembly finds that Hurricane Florence was one of  
13                  the strongest storms to form in the Atlantic Ocean in the history of North Carolina, reaching wind  
14                  speeds of up to 140 miles an hour and covering 500 miles; making landfall on September 14,  
15                  2018; causing heavy rainfall, record flooding, high storm surge, and dozens of deaths in the State  
16                  as of the date of this act; and necessitating the declaration of a State of Emergency for the State  
17                  by the Governor and a Major Disaster Declaration by the President of the United States for  
18                  multiple counties in the State.

19                  **SECTION 2.1.(b)** The General Assembly finds that as a result of Hurricane Florence  
20                  the following has occurred:

- 21                  (1)       Central and southeastern North Carolina suffered significant damage to public  
22                  and private property.



- 1                   (2) Essential utility services and systems and other critical infrastructure have  
2                   been seriously disrupted.
- 3                   (3) Over 880,000 people have lost power, thousands of people have been  
4                   displaced from their homes, and 1,600 roads have been closed.
- 5                   (4) Riverine flooding began at the start of Hurricane Florence, and the effects  
6                   continue to be felt across the State. Several large rivers reached and exceeded  
7                   major flooding levels.
- 8                   (5) As of the date of this act, twenty-eight of the State's counties have been  
9                   declared a major disaster by the President of the United States under the  
10                  Stafford Act (P.L. 93-288), with others requested and pending approval.
- 11                  (6) North Carolinians have lost their lives, their loved ones, their homes, their  
12                  communities, their schools and houses of worship, their life savings, their  
13                  businesses and places of employment, their possessions, their pets, and their  
14                  ways of life.
- 15                  (7) Entire towns throughout eastern North Carolina were flooded to the rooftops  
16                  as the record storm surge combined with water levels of rivers and streams  
17                  crested at flood-stage heights far beyond those ever seen before in this State.
- 18                  (8) Thirty-four states assisted North Carolina in addressing the devastation caused  
19                  by Hurricane Florence.
- 20                  (9) Thousands of emergency responders, National Guard members, and other  
21                  volunteers worked to respond and assist disaster areas during and after the  
22                  time the storm made landfall.
- 23                  (10) Swift action by the General Assembly is necessary to provide relief to and  
24                  facilitate recovery efforts for the citizens of North Carolina devastated from  
25                  the Hurricane.
- 26                  (11) Assessments from the damages resulting from Hurricane Florence are  
27                  ongoing, and Public Assistance projects are in planning stages to repair  
28                  facilities and roads, remove debris, and otherwise effectuate cleanup and  
29                  repair.
- 30                  (12) Further assistance by the General Assembly will be needed on behalf of the  
31                  people and local governments who have suffered damage to public buildings,  
32                  roads, wastewater treatment plants, and other critical infrastructure.

### PART III. CREATION OF HURRICANE FLORENCE DISASTER RECOVERY FUND

35                  **SECTION 3.1.(a)** The Hurricane Florence Disaster Recovery Fund is established.

36                  The purpose of the Fund is to provide necessary and appropriate relief and assistance from the  
37                  effects of Hurricane Florence, consistent with the provisions of this act, subsequent legislation  
38                  addressing the effects of Hurricane Florence. The Fund shall be maintained as a special fund and  
39                  administered by the Office of State Budget and Management or by another State agency, as  
40                  determined by the Governor, to carry out the provisions of this and subsequent acts necessitated  
41                  as a result of Hurricane Florence. All State and federal funds appropriated for Hurricane Florence  
42                  relief and recovery efforts shall be budgeted and accounted for in the Fund established in this  
43                  section.

44                  **SECTION 3.1.(b)** Funds shall be drawn from the Fund only as needed upon  
45                  justification by a State agency as evidence of the need for funds related to Hurricane Florence  
46                  recovery efforts.

47                  **SECTION 3.1.(c)** Funds in the Fund that are not expended, made subject to an  
48                  encumbrance, or disbursed shall remain available to implement the provisions of this act and  
49                  subsequent acts necessitated as a result of Hurricane Florence until the General Assembly directs  
50                  the reversion of the unexpended funds. Funds received by a State agency from the Fund that are  
51                  not expended, made subject to an encumbrance, or disbursed to another entity at the end of each

1 fiscal year shall revert to the Fund. Funds received by a non-State entity from the Fund that, after  
2 three years, are not expended, made subject to an encumbrance, or disbursed to a subgrantee shall  
3 be returned to the Fund.

## 5 PART IV. FUNDING OF DISASTER RELIEF

### 7 APPROPRIATIONS AND ALLOCATIONS OF FUNDS FOR DISASTER RELIEF

8 **SECTION 4.1.** Notwithstanding G.S. 143C-4-2, the State Controller shall transfer  
9 the sum of fifty-six million five hundred thousand dollars (\$56,500,000) for the 2018-2019 fiscal  
10 year from the Savings Reserve in the General Fund to the Hurricane Florence Disaster Recovery  
11 Fund and these funds are appropriated within the Fund and shall be allocated as follows:

- 12 (1) Six million five hundred thousand dollars (\$6,500,000) to the Department of  
13 Public Instruction to supplement or replace lost compensation of school lunch  
14 employees due to school closures resulting from Hurricane Florence.
- 15 (2) Fifty million dollars (\$50,000,000) for the following purposes related to  
16 Hurricane Florence:
  - 17 a. To provide the State match for federal disaster assistance programs.
  - 18 b. To pay for the costs and the relief and assistance authorized by  
19 G.S. 166A-19.42(b). This sub-subdivision applies to the North  
20 Carolina counties that are or become designated under a major disaster  
21 declaration by the President of the United States under the Stafford  
22 Act (P.L. 93-288) as a result of Hurricane Florence.

### 24 EACH APPROPRIATION AND ALLOCATION IS MAXIMUM AND CONDITIONAL

25 **SECTION 4.2.** The appropriations and allocations made in this act are for maximum  
26 amounts necessary to implement this act. Savings shall be effected where the total amounts  
27 appropriated or allocated are not required to implement this act.

### 29 APPROPRIATION OF FEDERAL FUNDS

30 **SECTION 4.3.** Appropriation/Federal Funds. – Funds received on or after  
31 September 13, 2018, under the federal Stafford Act (P.L. 93-288) and other federal disaster  
32 assistance programs for State disasters as a result of Hurricane Florence are appropriated in the  
33 amounts provided in the notifications of award from the federal government or any entity acting  
34 on behalf of the federal government to administer federal disaster recovery funds. The Office of  
35 State Budget and Management and affected State agencies shall report all notifications of award  
36 to the Joint Legislative Commission on Governmental Operations and the Fiscal Research  
37 Division of the General Assembly.

## 39 PART V. IMPLEMENTATION OF ACT

### 41 INVOLVEMENT OF HISTORICALLY UNDERUTILIZED BUSINESSES

42 **SECTION 5.1.** It is the intent of the General Assembly that, during this time of  
43 rebuilding and relief efforts, each State agency should strive to acquire goods and services from  
44 historically underutilized business vendors, whether directly as principal contractors or indirectly  
45 as subcontractors or otherwise.

### 47 LEGISLATIVE REVIEW OF FEDERAL FUNDING AND REMAINING UNMET 48 NEEDS

49 **SECTION 5.2.** It is the intent of the General Assembly to review in 2018 and 2019  
50 the funds appropriated by Congress for disaster relief and to consider actions needed to address

1 any remaining unmet needs. It is also the intent of the General Assembly to review the adequacy  
2 of the measures funded by Section 4.1 of this act at that time.

#### 4 ELECTIONS RELIEF

5 **SECTION 5.3.(a)** In response to Hurricane Florence and its aftermath, for the  
6 November 2018 election only, the following shall apply:

- 7 (1) Notwithstanding G.S. 163A-865(d), 163A-883, and 163A-884, applications  
8 for voter registration for the November 2018 election may be submitted until  
9 5:00 P.M. on October 15, 2018. If the application for registration is submitted  
10 by mail, the application shall be postmarked no later than October 15, 2018.  
11 If the application for voter registration is submitted by facsimile transmission  
12 or transmission of a scanned document, a permanent copy of the completed,  
13 signed form shall be delivered to the county board of elections no later than  
14 October 20, 2018.
- 15 (2) For any site that has previously been designated a one-stop site for absentee  
16 ballots to be applied for and cast during the period required by  
17 G.S. 163A-1300(b) for the November 2018 election under G.S. 163A-1303, a  
18 county board of elections by unanimous vote may provide for a substitution  
19 of the one-stop site, provided that the change is solely to substitute a one-stop  
20 site that was damaged by Hurricane Florence or made otherwise inaccessible  
21 or impractical for use as a result of damage from Hurricane Florence.
- 22 (3) A county board of elections may adopt a resolution altering voting places for  
23 the November 2018 election, provided that the change is solely to substitute a  
24 voting place that was damaged by Hurricane Florence or made otherwise  
25 inaccessible or impractical for use as a result of damage from Hurricane  
26 Florence. Notwithstanding G.S. 163A-1045(a) and any other notice  
27 requirements provided in statute, the county board shall provide notice of the  
28 change in location in the most expedient manner possible. This notice may be  
29 distributed through public service announcements, print, radio, television,  
30 online, and social media. If necessary to alter a voting place for a precinct that  
31 was damaged by Hurricane Florence or made otherwise inaccessible or  
32 impractical for use as a result of damage from Hurricane Florence, the county  
33 board may also make changes as provided in G.S. 163A-1047, 163A-1048,  
34 and 163A-1049.

35 **SECTION 5.3.(b)** Subsection (a) of this section (i) is effective when it becomes law,  
36 (ii) applies only in the counties designated under a major disaster declaration by the President of  
37 the United States under the Stafford Act (P.L. 93-288) as a result of Hurricane Florence as of  
38 October 2, 2018, and (iii) applies for the November 2018 election only.

39 **SECTION 5.3.(c)** County boards of elections shall educate the public, particularly  
40 individuals impacted or displaced by Hurricane Florence, about voting in the November 2018  
41 election as follows:

- 42 (1) Counties that maintain a board of elections Web site shall include information  
43 on that Web site about:
  - 44 a. Options to register to vote, including same day registration during the  
45 early voting period, and how to determine residency for voting  
46 purposes.
  - 47 b. Options to vote in the November 2018 election, including mail-in  
48 absentee voting and early one-stop voting. Information shall include  
49 locations and times of early one-stop voting.
- 50 (2) When publishing notices of elections under G.S. 163A-769(8) for the 2018  
51 general election, the notice shall include a brief statement regarding how to

1 obtain information on voting for individuals impacted or displaced by  
2 Hurricane Florence.

3 **SECTION 5.3.(d)** The Bipartisan State Board of Elections and Ethics Enforcement  
4 shall educate the public, particularly individuals impacted or displaced by Hurricane Florence,  
5 about voting in the November 2018 election. The State Board shall:

- 6 (1) Include on its Web site information about:
  - 7 a. Options to register to vote, including same day registration during the  
8 early voting period, and how to determine residency for voting  
9 purposes.
  - 10 b. Options to vote in the November 2018 election, including mail-in  
11 absentee voting and early one-stop voting.
- 12 (2) Distribute information about the options to register to vote, including same  
13 day registration during the early voting period, and options to vote in the  
14 November 2018 election, including mail-in absentee voting and early one-stop  
15 voting to State agencies, shelters, groups, and other organizations serving  
16 persons impacted or displaced by Hurricane Florence.
- 17 (3) Coordinate with the State and federal agencies to identify and notify as many  
18 persons as possible displaced by Hurricane Florence about the options to  
19 register to vote, including same day registration during the early voting period  
20 and options to vote in the November 2018 election, including mail-in absentee  
21 voting and early one-stop voting. When practicable, the State Board shall  
22 provide county specific information as to early one-stop voting locations and  
23 times.
- 24 (4) Disseminate information about the options to register to vote, including same  
25 day registration during the early voting period and options to vote in the  
26 November 2018 election, including mail-in absentee voting and early one-stop  
27 voting. Information may be distributed through public service  
28 announcements, print, radio, television, online, and social media.
- 29 (5) Assist any county board of elections altering one-stop sites and voting places  
30 for the November 2018 election under subsection (a) of this section in  
31 educating the public on the changes.

32 **SECTION 5.3.(e)** Notwithstanding G.S. 163A-1535 and G.S. 163A-1520, there is  
33 appropriated from the cash balance in Budget Code 68025 in the Bipartisan State Board of  
34 Elections and Ethics Enforcement the sum of four hundred thousand dollars (\$400,000) for the  
35 purpose of implementing this section. Expenditures of this appropriation are not subject to the  
36 provisions of Article 3 and Article 8 of Chapter 143 of the General Statutes.

## 38 MOSQUITO VECTOR POPULATION CONTROL

39 **SECTION 5.4.** It is the intent of the General Assembly to prevent large populations  
40 of floodwater mosquitoes from emerging following Hurricane Florence, as this could adversely  
41 impact the public health by hindering the State's response and recovery efforts and increasing the  
42 number of vector-borne illnesses. To that end, the General Assembly encourages the Department  
43 of Health and Human Services, Division of Public Health, to continue to work with local health  
44 departments to expedite mosquito control efforts in counties that are or become part of a disaster  
45 declaration by the President of the United States under the Stafford Act (P.L. 93-288) as a result  
46 of Hurricane Florence. For purposes of this section, mosquito control efforts include mosquito  
47 abatement activities, integrated mosquito management activities, education regarding mosquito  
48 bite avoidance, and the purchase and distribution of materials for personal prevention measures.

## 49 50 WAIVER OF CERTAIN DMV FEES

1           **SECTION 5.5.(a)** Notwithstanding G.S. 20-14, 20-37.7, 20-85, and 20-88.03, the  
2 Governor may waive any fees assessed by the Division of Motor Vehicles under those sections  
3 for the following:

- 4           (1)     A duplicate drivers license, duplicate commercial drivers license, or duplicate  
5 special identification card.  
6           (2)     A special identification card issued to a person for the first time.  
7           (3)     An application for a duplicate or corrected certificate of title.  
8           (4)     A replacement registration plate.  
9           (5)     An application for a duplicate registration card.  
10          (6)     Late payment of a motor vehicle registration renewal fee.

11          **SECTION 5.5.(b)** The waiver authorized under subsection (a) of this section only  
12 applies to residents of counties impacted by Hurricane Florence, as determined by the Governor.  
13 A resident is allowed a refund of any fee assessed and collected by the Division of Motor Vehicles  
14 and waived pursuant to this section. The Division shall post notice of the availability of a refund  
15 on its Web site.

16          **SECTION 5.5.(c)** This section is effective when it becomes law and applies to fees  
17 assessed or collected on or after September 13, 2018. This section expires December 31, 2018.

## 19          **WAIVER OF HOMEOWNERS RECOVERY FEE**

20          **SECTION 5.6.(a)** Notwithstanding G.S. 87-15.6, the Governor may waive the fee  
21 assessed by city and county building inspectors and credited to the Homeowners Recovery Fund  
22 for the reimbursement of homeowners suffering reimbursable losses in constructing or altering a  
23 single-family residential dwelling unit.

24          **SECTION 5.6.(b)** The waiver authorized under subsection (a) of this section only  
25 applies to residents of counties impacted by Hurricane Florence, as determined by the Governor.  
26 A permit applicant is allowed a refund of any fee assessed and collected by city and county  
27 building inspectors and waived pursuant to this section. A city or county subject to this section  
28 shall post notice of the availability of a refund on its Web site.

29          **SECTION 5.6.(c)** This section is effective when it becomes law and applies to  
30 applications for issuance of a permit subject to the Homeowners Recovery Fund fee that were  
31 received on or after September 13, 2018. This section expires December 31, 2018.

## 33          **ADDITIONAL LIMITATIONS ON USE OF FUNDS**

34          **SECTION 5.7.** The Governor shall ensure that funds appropriated in this act are  
35 expended in a manner that does not adversely affect any person's or entity's eligibility for federal  
36 funds that are made available, or that are anticipated to be made available, as a result of Hurricane  
37 Florence. The Governor shall also, to the extent practicable, avoid using State funds to cover  
38 costs that will be, or likely will be, covered by federal funds.

## 40          **PART VI. EFFECTIVE DATE**

41          **SECTION 6.1.** Except as otherwise provided, this act is effective when it becomes  
42 law.
