1 A SENATE RESOLUTION ADOPTING THE PERMANENT RULES OF THE SENATE FOR  
2 THE 2018 THIRD EXTRA SESSION OF THE 2017 GENERAL ASSEMBLY.

3 Be it resolved by the Senate:

4 **SECTION 1.** The permanent rules of the 2017 Regular Session, with the following  
5 amendments, are the rules governing the 2018 Third Extra Session of the General Assembly:

6 **RULE 32. List of standing/select committees.** – The standing committees shall be:

7 Appropriations/Base Budget

8 Education/Higher Education

9 Finance

10 Rules and Operations of the Senate

11 All committees shall be comprised of the members who were appointed to those  
12 committees during the 2017 Regular Session.

13 **RULE 40. Introduction of bills.** – Every bill filed for introduction shall contain on  
14 the Senate e-jacket the title of the document and the name of the Senator or Senators sponsoring  
15 it. The Senate e-jacket shall be delivered by the primary sponsor of the document, or by that  
16 member's legislative assistant, with the prescribed authorization form signed by the primary  
17 sponsor and by that member's legislative assistant, to the Office of the Senate Principal Clerk.

18 **RULE 40.1. Limitation on introduction and consideration of resolutions and  
19 bills.** – The only resolutions that may be introduced or considered in the Senate are resolutions  
20 establishing the rules governing the Third Extra Session and adjourning the Third Extra Session  
21 sine die. The only bills, parts of bills, or amendments to bills that may be introduced or considered  
22 in the Senate are bills, parts of bills, or amendments to bills addressing disaster recovery related  
23 to Hurricane Florence.

24 **RULE 41.** (Reserved).

25 **RULE 42. Reference of appropriation and finance bills.** – (a) All bills introduced  
26 in the Senate providing for appropriations from the State, or any subdivision thereof, or waiving  
27 fees or other revenues payable to the State, its agencies, its licensing boards, or any of its  
28 subdivisions shall, before being considered by the Senate, be referred to the Committee on  
29 Appropriations/Base Budget and bills referred to other committees carrying any such provisions  
30 shall be reported to the Senate as being bills to be referred to the Appropriations/Base Budget  
31 Committee before proper action may be taken by the Senate.

32 **RULE 43. First reading; reference to committee.** – All bills introduced and all  
33 House bills received upon a message from the House of Representatives, upon presentation to  
34 the Senate, shall be read in the regular order of business by their number and title, which shall  
35 constitute the first reading of the bill on the day on which they are received. The Chair of the  
36 Committee on Rules and Operations of the Senate or the President Pro Tempore may refer to a



1 Senate committee all bills introduced in the Senate or received from the House of  
2 Representatives. Upon the referral being made, the Chair of the Committee on Rules and  
3 Operations of the Senate shall notify the Principal Clerk of the Senate of the referral, and the  
4 Reading Clerk shall announce the referral of the bill. The Principal Clerk shall inform the  
5 Presiding Officer of the referral. The title and referral shall be entered upon the Journal. Bills  
6 may be referred to more than one committee serially.

7       **RULE 43.1. Second reading.** – All bills reported by committee shall be placed before  
8 the Senate for second reading and immediate consideration upon passage.

9       **RULE 45.1. Action on amendment or committee substitute.** – If any committee  
10 recommends adoption of an amendment or committee substitute of a bill or resolution, the  
11 amendment or committee substitute shall be considered adopted upon the reading of the  
12 committee report. The bill or resolution, as amended, or its adopted committee substitute may be  
13 placed on the calendar for the same legislative day or re-referred if the bill or resolution was  
14 serially referred. The committee substitute's original bill or resolution shall lie on the table.

15       **RULE 50. Third reading requirements.** – When a bill or resolution has passed its  
16 second reading, it shall be placed on the calendar for immediate consideration on its third reading,  
17 unless prohibited by Section 23 of Article II of the North Carolina Constitution.

18       **RULE 56.1. Amendments and committee substitutes adopted by the House to**  
19 **bills originating in the Senate.** – (a) Whenever the House has adopted an amendment or a  
20 committee substitute for a bill originating in the Senate and has returned the bill to the Senate for  
21 concurrence in that amendment or committee substitute, the Senate may concur in that  
22 amendment or committee substitute on the same legislative day.

23       **RULE 59.** (Reserved).

24       **RULE 59.2. Vetoed bills.** – (a) The Principal Clerk, or in the Clerk's absence an  
25 employee designated by the Principal Clerk, is designated the Senate Officer to receive bills  
26 vetoed by the Governor. If the veto message is received on a day when the Senate is in session,  
27 it may be read in the Senate on the day of its receipt. If the veto message is received on a day  
28 when the Senate is not in session, or if it was not read on the legislative day when it was received,  
29 it shall be read on the next legislative day.

30       (b) Upon a veto message's being read in the Senate, the Chair of the Committee  
31 on Rules and Operations of the Senate, or in the absence of the Chair, the President Pro Tempore  
32 of the Senate shall either refer the bill and the Governor's objections and veto message to  
33 committee or place the bill on the calendar for a day certain.

34       **SECTION 2.** This resolution is effective upon adoption.
