5		ECTION 1. Section 3 of S.L. 1987-322 reads as rewritten:	
6	"Sec. 3. Beginning with members elected in 1988, members of the McDowell County Board of Elections Education shall serve four year terms, except that in the 1002 election, for the four		
7	of <u>Elections-Education</u> shall serve four-year terms, except that in the 1992 election, for the four Marion district seats up for election that year, the three highest vote-getters shall be elected for		
8 9	four-year terms, and the next highest vote-getter shall be elected for a two-year term. In the case

26	To be eligible for election to the Board from an attendance zone, a candidate must reside in the		
27	attendance zone. Each seat shall appear separately on the ballot, but all the qualified voters of the		
28	entire county are eligible to vote on all the seats. To be eligible to serve as a member of the Board		
29	representing an attendance zone, a person must reside in the attendance zone; however, a change		
30	in the boundaries of attendance zones shall not affect the ability of any person to complete his or		
31	her term of office. If a vacancy occurs on the board, the person appointed as the replacement		
32	must reside in the attendance zone which was served by the departing member. In the event the		
33	McDowell C	ounty Board of Education changes the legal name of an elementary school, the

- 1 Board shall reflect, in policy, the corresponding attendance zone of the renamed school to the
- 2 3 elementary school named in this act."
- **SECTION 2.** This act is effective when it becomes law.
