6	Whereas, "Land of Waterfalls" has been used to describe the area since the early			
7	1900s, including the City of Brevard's and Transylvania County's official seal and logo,

9	Whereas, this area has a long history as a tourist destination, with enjoyment of			
10		waterfalls consistently listed on visitor surveys as a primary reason for visitation; and		
11 12	Whereas, this area features numerous iconic and nationally known waterfalls like Looking Glass Falls, Sliding Rock, Hooker Falls, High Falls, Triple Falls, Rainbow Falls, and

15	feature films, including Thunder Road, The Last of the Mohicans, and The Hunger Games, as

26	The General Assembly of North Carolina enacts:			
27		SECTION 1. Chapter 145 of the General Statutes is amended by adding a new		
28	section to read:			
29	" <u>§ 145-52. Official land of waterfalls.</u>			
30		The City of Brevard, the Town of Rosman, and Transylvania County are designated as North		
31		Carolina's official land of waterfalls."		
32	SI	ECTION 2. This act is effective when it becomes law.
