#### A BILL TO BE ENTITLED

# AN ACT TO PROVIDE ADDITIONAL FLEXIBILITY TO LOCAL SCHOOL ADMINISTRATIVE UNITS LOCATED IN SAMPSON COUNTY AND WAYNE COUNTY IN ADOPTING THE SCHOOL CALENDAR.

5 Whereas, the local boards of education for the local school administrative units 6 located in Sampson County and Wayne County should be able to schedule school opening and 7 closing dates for any school in their respective units to coincide with the opening and closing 8 dates of Sampson Community College or Wayne Community College; and

9 Whereas, school calendar flexibility would benefit all students in the local school 10 administrative units of Sampson County and Wayne County who are enrolled in classes through 11 Sampson Community College or Wayne Community College by allowing them to align their fall 12 and spring semesters with the fall and spring semesters at their respective community college; 13 and

Whereas, school calendar flexibility would allow local school administrative units and community colleges in Sampson County and Wayne County to meet the workforce development needs in their respective counties more effectively than the current structure by helping high school and college students develop the skills necessary for business and industry; Now, therefore,

19 The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 115C-84.2(d) reads as rewritten:

21 Opening and Closing Dates. - Local boards of education shall determine the dates of "(d) 22 opening and closing the public schools under subdivision (a)(1) of this section. Except for 23 year-round schools, the opening date for students shall be no earlier than the Monday closest to 24 August 26, and the closing date for students shall be no later than the Friday closest to June 11. 25 On a showing of good cause, the State Board of Education may waive the requirement that the 26 opening date for students be no earlier than the Monday closest to August 26 and may allow the 27 local board of education to set an opening date no earlier than the Monday closest to August 19, 28 to the extent that school calendars are able to provide sufficient days to accommodate anticipated 29 makeup days due to school closings. A local board may revise the scheduled closing date if necessary in order to comply with the minimum requirements for instructional days or 30 instructional time. For purposes of this subsection, the term "good cause" means that schools in 31 32 any local school administrative unit in a county have been closed eight days per year during any 33 four of the last 10 years because of severe weather conditions, energy shortages, power failures, 34 or other emergency situations.

1	The required opening and closing dates under this subsection shall not apply to any school
1	
2	that a local board designated as having a modified calendar for the 2003-2004 school year or to
3	any school that was part of a planned program in the 2003-2004 school year for a system of
4	modified calendar schools, so long as the school operates under a modified calendar."
5	SECTION 2. This act applies only to Sampson County Schools and Wayne County
6	Schools.

7 SECTION 3. This act is effective when it becomes law and applies beginning with
8 the 2019-2020 school year.
