6	Whereas, in the last ten years, cases of communicable diseases have increased over
7	two hundred percent (200%); and
8	Whereas, State funding to support communicable disease efforts has remained
9	stagnant, thereby creating pressures on local governments to meet these demands; and
10	Whereas, in the 2017-2018 fiscal year, general communicable disease control cost
11	twenty million six hundred thousand dollars (\$20,600,000), and State funding provided less than
12	five percent (5%) of that cost, or approximately eight hundred sixty-seven thousand dollars
13	(\$867,000), leaving the remaining nineteen million eight hundred thousand dollars (\$19,800,000)
14	to be borne by local governments; and
15	Whereas, State law requires local health departments to implement control measures
16	to prevent the spread of all reportable communicable diseases or communicable conditions and
17	any other communicable disease or communicable condition that represents a significant threat
18	to the public health; and Whenese level health departments provide at no cost to the potient, the even instign
19 20	Whereas, local health departments provide, at no cost to the patient, the examination
20 21	and treatment for tuberculosis disease and infection and for sexually transmitted diseases
21 22	designated by the Commission for Public Health; and
22 23	Whereas, local health departments must have the infrastructure and capacity to perform communicable disease control and surveillance activities in order to prevent the spread
23 24	of disease and protect the public health; Now, therefore,
24 25	The General Assembly of North Carolina enacts:
23 26	SECTION 1. It is the intent of the General Assembly to protect the public health by
20 27	providing additional State funds to address increased demands associated with communicable
28	and emerging infectious diseases. To that end, there is appropriated from the General Fund to the
28 29	Department of Health and Human Services, Division of Public Health, the sum of eight million
2) 30	dollars (\$8,000,000) in recurring funds for the 2019-2020 fiscal year and the sum of eight million
31	dollars (\$8,000,000) in recurring funds for the 2020-2021 fiscal year, to be allocated to local
32	health departments to expand local infrastructure for activities associated with the surveillance,
33	detection, control, and prevention of communicable diseases. In allocating these funds to local
33 34	health departments under this section, for each year of the 2019-2021 fiscal biennium, the
35	Division of Public Health shall divide four million dollars (\$4,000,000) equally among the local
36	health departments. The Division of Public Health shall allocate the remaining four million

1 dollars (\$4,000,000) to local health departments based upon the percentage of the State

2 population served by each of the local health departments. Local health departments shall use all

- 3 funds allocated under this section to supplement and not supplant existing funds for the
- 4 surveillance, detection, control, and prevention of communicable diseases.
- 5 **SECTION 2.** This act becomes effective July 1, 2019.
