

6	PART I. INTRODUCTION AND TITLE OF ACT

8	INTRODUCTION
9	SECTION 1.1. The appropriations made in this act are for maximum amounts
10	necessary to provide the services and accomplish the purposes described in the budget in
11	accordance with the State Budget Act, Chapter 143C of the General Statutes. Savings shall be
12	effected where the total amounts appropriated are not required to perform these services and
13	accomplish these purposes, and the savings shall revert to the appropriate fund at the end of each
14	fiscal year, except as otherwise provided by G.S. 143C-1-2(b).

16	TITLE OF ACT
17	<b>SECTION 1.2.</b> This act shall be known as the "Current Operations Appropriations"
18	Act of 2019."

19	<b>SECTION 6.1.</b> The provisions of the State Budget Act, Chapter 143C of the General
20	Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act
21	by reference.

23	MOST TEXT APPLIES ONLY TO THE 2019-2021 FISCAL BIENNIUM
24	SECTION 6.2. Except for statutory changes or other provisions that clearly indicate
25	an intention to have effects beyond the 2019-2021 fiscal biennium, the textual provisions of this
26	act apply only to funds appropriated for, and activities occurring during, the 2019-2021 fiscal
27	biennium.

30	<b>SECTION 6.3.</b> The headings to the parts and sections of this act are a convenience
31	to the reader and are for reference only. The headings do not expand, limit, or define the text of
32	this act, except for effective dates referring to a part.
