#### 1 A BILL TO BE ENTITLED 2 AN ACT TO SUBMIT TO THE VOTERS OF NORTH CAROLINA A REFERENDUM 3 URGING CONGRESS TO PASS AN AMENDMENT TO THE CONSTITUTION OF THE 4 UNITED STATES DECLARING THAT CONSTITUTIONAL RIGHTS BELONG ONLY 5 TO INDIVIDUALS AND NOT TO CORPORATIONS OR OTHER ARTIFICIAL 6 ENTITIES AND THAT CONSTITUTIONALLY PROTECTED FREE SPEECH 7 EXCLUDES THE UNLIMITED SPENDING OF MONEY ON POLITICAL CAMPAIGN 8 CONTRIBUTIONS. 9 Whereas, Section 2 of Article I of the Constitution of North Carolina asserts that "[a]ll 10 political power is vested in and derived from the people; all government of right originates from 11 the people, is founded upon their will only, and is instituted solely for the good of the whole"; 12 and 13 Whereas, free and fair elections, as well as honest representation, are essential to 14 self-determination and self-governance as described in the Declaration of Independence and 15 established in the Constitution of the United States; and Whereas, the American people have lost faith in the political process because their 16 17 voices are not heard, nor their interests represented, and thus, an ever smaller percentage of 18 Americans is motivated to vote: and 19 Whereas, the Constitution of the United States makes no mention of corporations or 20 other artificial entities and there are no provisions extending rights to such entities; however, 21 through a series of decisions equating a "corporation" with a "person," the United States Supreme 22 Court has extended to corporations the constitutional rights and protections intended for people 23 only; and 24 Whereas, unlike human beings, corporations can exist in perpetuity and in many 25 countries at the same time, and as a result, many large corporations, both foreign and domestic, invest in campaigns to invalidate or bypass regulatory law intended to protect the public, and as 26 such, corporate participation in the political process often conflicts with the public interest; and 27 28 Whereas, money is property and not speech and nowhere in the Constitution of the 29 United States is money equated with speech; and 30 Whereas, because advertising is limited and costly, equating the spending of money 31 with free speech gives those with the most money the most speech; and 32 Whereas, whenever special interests, including very wealthy individuals, are able to 33 spend unlimited amounts of money on political speech, candidates and officeholders can be 34 corrupted and intimidated and the free speech of most citizens is drowned out and denied; and 35

Whereas, monopolizing public speech neither promotes nor protects free speech; and

1 Whereas, anonymous contributions and spending for political gain promote 2 dishonesty and corruption, preventing voters from assessing the motives of the speaker; and 3 Whereas, the public must be able to hold funders of political speech accountable when 4 their messages prove false or misleading; and 5 Whereas, full and prompt disclosure of funding sources is essential to an informed 6 electorate, fair elections, and effective governance; and 7 Whereas, Article V of the Constitution of the United States empowers the people and 8 the states to use the amendment process to correct egregious decisions by the United States 9 Supreme Court that subvert our representative government; Now, therefore, 10 The General Assembly of North Carolina enacts: 11 **SECTION 1.** A referendum shall be submitted to the qualified voters of the State of 12 North Carolina at a statewide election to be held November 3, 2020, to determine whether the 13 people of North Carolina choose to urge the United States Congress to pass an amendment to the 14 Constitution of the United States declaring that constitutional rights belong only to individuals and not to corporations or other artificial entities and that constitutionally protected free speech 15 16 excludes the unlimited spending of money on political campaign contributions. The referendum 17 shall be held under the laws then governing elections in the State. Ballots, voting systems, or 18 both may be used in accordance with Chapter 163A of the General Statutes. The question to be 19 used in the voting systems and ballots shall be: 20 "[] FOR [] AGAINST 21 Urging the United States Congress to amend the Constitution of the United States 22 declaring that constitutional rights belong only to individuals and not to corporations or other 23 artificial entities and that constitutionally protected free speech excludes the unlimited spending 24 of money on political campaign contributions." 25 **SECTION 2.** If a majority of votes cast on the question are in favor of the referendum 26 set out in Section 1 of this act, the State Board of Elections shall certify the referendum to the 27 Secretary of State. The Secretary of State shall enroll the referendum so certified among the 28 permanent records of that office and shall certify the results of the referendum to the President 29 of the United States, each member of the United States Congress, the Governor of the State of

- 30 North Carolina, and each member of the North Carolina General Assembly.
- 31 **SECTION 3.** This act is effective when it becomes law.
