A BILL TO BE ENTITLED

AN ACT TO REQUIRE PUBLIC SCHOOLS TO PERMIT PATRIOTIC SOCIETY PRESENTATIONS AT THE BEGINNING OF EACH SCHOOL YEAR FOR NO MORE THAN ONE HOUR.

The General Assembly of North Carolina enacts:

SECTION 1.(a) G.S. 115C-81.60 is amended by adding a new subsection to read:

"(c) Patriotic Society Presentations in Schools. –

- (1) The principal of each school shall allow representatives of a patriotic society the opportunity to speak with students at the beginning of each school year during instructional hours to inform the students of how the patriotic society may further the students' educational interest and civic involvement to better their schools, communities, and themselves. For the purposes of this subsection, a patriotic society is a group or organization listed in Title 36 of the United States Code that is a youth membership organization with an educational purpose that aligns with the standard course of study and promotes civic involvement.
- (2) The representatives shall provide to the principal oral or written notice of the patriotic society's desire to speak with students. The principal shall provide oral or written approval of the specific day and time for the representatives to address the students for no more than one hour."

SECTION 1.(b) G.S. 115C-218.75 is amended by adding a new subsection to read: "(g) Patriotic Society Presentations in Schools. —

- (1) A charter school shall allow representatives of a patriotic society the opportunity to speak with students at the beginning of each school year during instructional hours to inform the students of how the patriotic society may further the students' educational interest and civic involvement to better their schools, communities, and themselves. For the purposes of this subsection, a patriotic society is a group or organization listed in Title 36 of the United States Code that is a youth membership organization with an educational purpose that aligns with the standard course of study and promotes civic involvement.
- (2) The representatives shall provide to the charter school oral or written notice of the patriotic society's desire to speak with students. The charter school shall provide oral or written approval of the specific day and time for the representatives to address the students for no more than one hour."

SECTION 1.(c) G.S. 115C-238.66 is amended by adding a new subdivision to read:

For the purposes of this subdivision, a patriotic society is 24 a group or organization listed in Title 36 of the United States Code that 25 is a youth membership organization with an educational purpose that 26 aligns with the standard course of study and promotes civic involvement. 27 28 The representatives shall provide to the laboratory school oral or <u>b.</u> 29 written notice of the patriotic society's desire to speak with students. 30 The laboratory school shall provide oral or written approval of the specific day and time for the representatives to address the students for 31 no more than one hour." 32 33 **SECTION 2.** This act is effective when it becomes law and applies beginning with 34 the 2019-2020 school year.
