## A BILL TO BE ENTITLED

AN ACT TO TEMPORARILY MODIFY THE REQUIREMENTS FOR ISSUANCE OF A LIMITED LEARNER'S PERMIT AND PROVISIONAL DRIVERS LICENSE.

The General Assembly of North Carolina enacts:

**SECTION 1.(a)** Notwithstanding G.S. 20-11(c)(3), for the first three months after issuance, the permit holder may drive only between the hours of 5:00 A.M. and 9:00 P.M.

**SECTION 1.(b)** Notwithstanding G.S. 20-11(c)(4), after the first three months after issuance, the permit holder may drive at any time.

**SECTION 1.(c)** Notwithstanding G.S. 20-11(d)(1), a person only has to have held a limited learner's permit issued by the Division for at least six months.

**SECTION 1.(d)** Notwithstanding G.S. 20-11(h)(2), a person may obtain a full provisional license if the person has completed a drivers education program that meets the requirements of the Superintendent of Public Instruction, has held the license issued by the other state for at least six months, and has not been convicted during the preceding six months of a motor vehicle moving violation, a seat belt infraction, or an offense committed in another jurisdiction that would be a motor vehicle moving violation or seat belt infraction if committed in this State.

**SECTION 1.(e)** Notwithstanding G.S. 20-11(h)(3), a person may obtain a limited provisional license if the person has completed a drivers education program that meets the requirements of the Superintendent of Public Instruction but either did not hold the license issued by the other state for at least six months or was convicted during the preceding six months of a motor vehicle moving violation, a seat belt infraction, or an offense committed in another jurisdiction that would be a motor vehicle moving violation or seat belt infraction if committed in this State.

**SECTION 1.(f)** Notwithstanding G.S. 20-11(h1)(1), a person may obtain a limited provisional license if the person has completed a drivers education program that meets the requirements of the Superintendent of Public Instruction, held the restricted license issued by the other state for at least six months, and whose parent or guardian certifies that the person has not been convicted during the preceding six months of a motor vehicle moving violation, a seat belt infraction, or an offense committed in another jurisdiction that would be a motor vehicle moving violation or seat belt infraction if committed in this State.

**SECTION 1.(g)** Notwithstanding G.S. 20-11(h1)(2), a person may obtain a limited learner's permit if the person has completed a drivers education program that meets the requirements of the Superintendent of Public Instruction but either did not hold the restricted license issued by the other state for at least six months or was convicted during the preceding six months of a motor vehicle moving violation, a seat belt infraction, or an offense committed in

**SECTION 4.** This act is effective when it becomes law and applies to persons that turned 15 years of age on or after March 1, 2020. This act expires June 30, 2021.
