1 A BILL TO BE ENTITLED 2 AN ACT TO INCREASE THE LICENSING FEES OF THE CURRITUCK COUNTY GAME 3 COMMISSION. 4 The General Assembly of North Carolina enacts: 5 SECTION 1.(a) Section 8 of Chapter 1436 of the 1957 Session Laws, as amended 6 by Section 6 of Chapter 622 of the 1981 Session Laws and by Section 1 of S.L. 1997-163 and by Section 51 of S.L. 1997-456, reads as rewritten: 7 8 "Section 8. To obtain a license for either a stationary bush blind or a floating bush blind, the 9 applicant shall apply in writing to the clerk to the Game Commission enclosing: Twenty-five dollars (\$25.00) Forty dollars (\$40.00) if the applicant is a 10 (1)11 resident of North Carolina; or 12 Two hundred fifty dollars (\$250.00) if the applicant is not a resident of North (2)13 Carolina. 14 In addition to this nonrefundable application fee, each application shall be accompanied by a 15 nonrefundable processing fee of ten dollars (\$10.00). Applicants shall submit proof of North 16 Carolina residency along with each application. 17 Applicants who are not residents of North Carolina but who were the holders of licensed blinds for the 1996-97 waterfowl season shall be charged as North Carolina residents for all 18 19 subsequent renewals of that application. However, this exemption terminates if the blind license 20 is not renewed during any subsequent annual renewal period and is not transferable to any 21 different blind location. 22 Float blinds when licensed shall bear the license number or tag, and the same shall be 23 displayed in a prominent or conspicuous place upon the blind." 24 SECTION 1.(b) Subsection (b) of Section 10 of Chapter 1436 of the 1957 Session 25 Laws, as amended by Section 7 of Chapter 622 of the 1981 Session Laws and Section 4 of Chapter 764 of the 1983 Session Laws, and by Section 2 of S.L. 1997-163, reads as rewritten: 26 27 Application must be filed on or before August 1 of each year to insure timely "(b) 28 consideration. To obtain a license for a point blind, the applicant shall apply in writing to the clerk to the Game Commission enclosing twenty five dollars (\$25.00). forty dollars (\$40.00). In 29 30 addition to the application fee, each application shall be accompanied by a nonrefundable 31 processing fee of ten dollars (\$10.00)." SECTION 1.(c) Section 16 of Chapter 1436 of the 1957 Session Laws, as amended 32 33 by Section 1 of Chapter 1178 of the 1971 Session Laws, reads as rewritten: 34 "Sec. 16. The use of airboats on the public waters of Currituck County Game Commission 35 with the approval of the North Carolina Wildlife Resource Commission shall have authority to 36 restrict or prohibit the use of air boats on Currituck Sound is prohibited from September 1 of

- 1 <u>each year to April 1 of each the following year.</u> All boats powered with gasoline, oil or similarly
- 2 operated engines shall use efficient mufflers in Currituck County except when otherwise
- 3 authorized by the Federal Government."
- 4 SECTION 2. This act becomes effective October 1, 2022, and applies to applications
- 5 for licenses on or after that date.
