## **General Assembly Of North Carolina**

SECTION 2.(c) Report. – The Department of Agriculture and Consumer Services
shall provide an interim report on its implementation of this act no later than September 1, 2021,
and a final report no later than January 1, 2022, to the Joint Legislative Oversight Committee on
Agriculture and Natural and Economic Resources and the Fiscal Research Division.

5 **SECTION 3.** Except as otherwise provided, this act is effective when it becomes 6 law.
