SECTION 2. There is appropriated from the General Fund to the Administrative Office of the Courts the sum of one hundred thirty-seven thousand seventy-eight dollars (\$137,078) in recurring funds for each fiscal year of the 2021-2023 fiscal biennium and six thousand fifty-six dollars (\$6,056) in nonrecurring funds for the 2021-2022 fiscal year to be used to hire two additional magistrates to serve in Mecklenburg County pursuant to Section 1 of this act.

SECTION 3. This act becomes effective July 1, 2021.
