- 5 The General Assembly of North Carolina enacts: 6

SECTION 1. G.S. 105-277.02(a) reads as rewritten:

7 Residential Real Property. - Residential real property held for sale by a builder is "(a) designated a special class of property under authority of Article V, Sec. 2(2) of the North Carolina 8 9 Constitution. For purposes of this subsection, "residential real property" is real property that is intended to be sold and used as an individual's residence immediately or after construction of a 10 residence, and the term excludes property that is either occupied by a tenant or used for 11 commercial purposes such as residences shown to prospective buyers as models. Any increase 12 in value of this classified property attributable to subdivision of, of the property, improvements 13 other than buildings, buildings made on the property, or the construction of either a new 14 single-family residence-residence, a townhouse, or a duplex on the property by the builder is 15 excluded from taxation under this Subchapter as long as the builder continues to hold the property 16 for sale. In no event shall this exclusion extend for more than three years from the time the 17 improved property was first subject to being listed for taxation by the builder." 18 19 **SECTION 2.** This act is effective for taxes imposed for taxable years beginning on

20 or after July 1, 2022.
