The General Assembly of North Carolina enacts:

# INTRODUCTION

**SECTION 1.1.** The appropriations made in this act are for the maximum amounts necessary to provide the services required to accomplish the objectives necessary for the State's continuing recovery from the COVID-19 pandemic.

# 1112 TITLE OF ACT

**SECTION 1.2.** This act shall be known, and may be cited, as the "Omnibus Coronavirus Relief Act of 2021."

## **APPROPRIATIONS**

**SECTION 2.1.(a)** Pandemic recovery appropriations from the General Fund of the State for the maintenance of the State departments, institutions, and agencies, and for other purposes relating to the COVID-19 pandemic, as herein enumerated, are made for the biennium ending June 30, 2023, in accordance with the provisions of this act.

**SECTION 2.1.(b)** Federal funds for pandemic recovery for other related purposes as enumerated are made for the biennium ending June 30, 2023, in accordance with the provisions of this act.

#### STATE BUDGET ACT

**SECTION 3.1.** The provisions of the State Budget Act, Chapter 143C of the General Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act by reference.

#### MOST TEXT APPLIES TO 2021-2023 BIENNIUM

**SECTION 4.1.** Except for statutory changes or other provisions that clearly indicate an intention to have effects beyond the 2021-2023 fiscal biennium, the textual provisions of this act apply only to funds appropriated for, and activities occurring during, the 2021-2023 fiscal biennium.
