2	AN ACT TO REVISE REQUIREMENTS REGARDING THE TRANSFER OF FUNDS FROM
3	A LOCAL SCHOOL ADMINISTRATIVE UNIT TO A CHARTER SCHOOL TO
4	INCENTIVIZE THE TIMELY TRANSFER OF FUNDS.
5	The General Assembly of North Carolina enacts:
6	SECTION 1. G.S. 115C-218.105 reads as rewritten:
7	"§ 115C-218.105. State and local funds for a charter school.
8	
9	(c) If a student attends a charter school, the local school administrative unit in which the
10	child resides shall transfer to the charter school an amount equal to the per pupil share of the local
11	current expense fund of the local school administrative unit for the fiscal year. The per pupil
12	share of the local current expense fund shall be transferred to the charter school within 30 days
13	of the later of (i) the receipt of monies into the local current expense fund. fund or (ii) the receipt
14	by a local school administrative unit of the enrollment verification and transfer request document
15	as provided under subsections (c2) and (c3) of this section from the charter school. Charter
16	schools shall send the enrollment verification and transfer request document to the local school
17	administrative units on a monthly basis. If the local school administrative unit receives additional
18	monies into the local current expense fund following the initial transfer to the charter school, the
19	local school administrative unit shall transfer the per pupil share of those additional monies to
20	the charter school within 30 days of receipt of those monies.
21	(c1) If a local school administrative unit receives written notice directed to the
22	superintendent and school finance officer from a charter school that the per pupil share of the
23	local current expense fund has not been transferred as required by subsection (c) of this section,
24	the local school administrative unit shall pay a late fee of three percent (3%) on the amount if the
25	monies are not electronically transferred or, if mailed, not postmarked within 15 days of the
26	notice. Interest on the amount owed to the charter school shall accrue at eight percent (8%)
27	annually until the transfer is made. A local school administrative unit shall not owe late fees and
28	interest on (i) any amounts not owed under subsection (c) of this section or (ii) per pupil amounts
29	owed for any student whose information is ultimately shown to be materially incorrect on the
30	enrollment verification and transfer request document shared with the local school administrative
31	unit. A local school administrative unit shall be given an additional 30 days to make the transfer
32	of the per pupil share of the local current expense fund to a charter school for any month in which

1 the charter school fails to send the enrollment verification and transfer request document with 2 the information required by subsection (c2) of this section. 3 The Superintendent of Public Instruction shall, in consultation with charter schools (c2)4 and local school administrative units, create a standardized enrollment verification and transfer request document that each charter school shall use to request the per pupil share of the local 5 6 current expense fund from the local school administrative units. Charter schools shall only be 7 required to list the name, age, grade, address, date of charter enrollment, date of charter withdrawal, district of residence, and student identification number of each student as provided 8 9 to the charter school by the student's parent or guardian in the enrollment verification and transfer 10 request document that the charter school submits to the local school administrative units. A 11 charter school, in its discretion, may take further steps to confirm the student's residence in a particular local school administrative unit. 12 The Superintendent of Public Instruction shall, in consultation with charter schools 13 (c3)14 and local school administrative units, create a standardized procedure that local school administrative units shall use when transferring the per pupil share of the local current expense 15 16 fund to charter schools. The standardized procedure for transfer of the per pupil share of the local 17 current expense fund shall require, to the extent practicable, that the local school administrative 18 units make the transfers by electronic transfer. 19 The local school administrative unit and charter school may use the process for (c4) 20 mediation of differences between the State Board and a charter school provided in 21 G.S. 115C-218.95(d) to resolve differences on calculation and transference of the per pupil share 22 of the local current expense fund. In the event the local school administrative unit and the charter 23 school disagree on the amount owed to the charter school, the local school administrative unit 24 may delay transfer of the disputed amount but shall not delay the transfer of the undisputed 25 amount. The amount transferred under this subsection that consists of revenue derived from 26 supplemental taxes shall be transferred only to a charter school located in the tax district for 27 which these taxes are levied and in which the student resides. 28 (d) The local school administrative unit shall also provide each charter school to which 29 it transfers a per pupil share of its local current expense fund with all of the following information 30 within the 30-day time period provided in subsection (c) of this section: 31 The total amount of monies the local school administrative unit has in each of (1)32 the funds listed in G.S. 115C-426(c). 33 The student membership numbers used to calculate the per pupil share of the (2)34 local current expense fund. 35 How the per pupil share of the local current expense fund was calculated. (3) 36 (4) Any additional records requested by a charter school from the local school 37 administrative unit in order for the charter school to audit and verify the 38 calculation and transfer of the per pupil share of the local current expense 39 fund. 40 In addition, the local school administrative unit shall provide to the State Board of Education all of the information required by this subsection for each charter school to which it transfers a 41 42 per pupil share of its local current expense fund. This information shall be provided to the State 43 Board of Education by November 1 of each year. The State Board shall adopt a policy to govern 44 the collection of this information. The State Board shall issue a letter of noncompliance to a local 45 school administrative unit that does not provide the State Board with the information required by 46 this subsection. 47 Prior to commencing an action under subsection (c) of this section, the complaining (e) 48 party shall give the other party 15 days' written notice of the alleged violation. The court shall 49 award the prevailing party reasonable attorneys' fees and costs incurred in an action under

subsection (c) of this section. The court shall order any delinquent funds, costs, fees, and interest 50

to be paid in equal monthly installments and shall establish a time for payment in full that shallbe no later than one year from the entry of any judgment.
