Where minimum educational standards are not met, yet the individual shows potential and a willingness to achieve the standards by extra study, they may be waived by the Commission for the reasonable amount of time it will take to achieve the standards required. Upon petition from a sheriff, the Commission may grant a waiver of any provisions of this section (17E-7) for any justice officer serving that sheriff."

6 **SECTION 1.(e)** In developing the standards and training required by subsections (a) 7 and (b) of this section, the North Carolina Criminal Justice Education and Training Standards 8 Commission and the North Carolina Sheriffs' Education and Training Standards Commission are 9 encouraged to adopt standards that provide training conducted by mental health professionals 10 and through face-to-face instruction.

11 SECTION 1.(f) The North Carolina Criminal Justice Education and Training 12 Standards Commission and the North Carolina Sheriffs' Education and Training Standards 13 Commission shall regularly provide information on any statewide mental health resources 14 specifically available to criminal justice officers or justice officers to all criminal justice agencies 15 or departments in the State that employ officers certified by either Commission.

16 **SECTION 1.(g)** All criminal justice agencies or departments in the State that employ 17 criminal justice officers certified by the North Carolina Criminal Justice Education and Training 18 Standards Commission or justice officers certified by the North Carolina Sheriffs' Education and 19 Training Standards Commission shall coordinate with the appropriate local management 20 entity/managed care organization (LME/MCO) or prepaid health plan, as defined under 21 G.S. 108D-1, to make information on State and local mental health resources and programs easily 22 available to all employees and develop policies to encourage employees to utilize the resources 23 available.

SECTION 1.(h) The North Carolina Criminal Justice Education and Training Standards Commission and the North Carolina Sheriffs' Education and Training Standards Commission shall jointly study the benefits, if any, of requiring physical fitness testing throughout the career of a law enforcement officer and shall also study whether that testing, if required, should be incrementally adjusted based upon the age of the law enforcement officer and report to the Joint Legislative Oversight Committee on Justice and Public Safety no later than March 31, 2022.

SECTION 1.(i) The North Carolina Criminal Justice Education and Training Standards Commission and the North Carolina Sheriffs' Education and Training Standards Commission shall implement the requirements of subsections (a) through (d) of this section no later than January 1, 2022. The requirements of subsections (c) and (d) of this section shall apply to certifications issued and employees entering employment on or after the implementation date of those requirements.

37 SECTION 1.(j) Subsections (a) through (d) of this section become effective January
 38 1, 2022, and apply to applications for law enforcement certification filed on or after that date.
 39 SECTION 2. The remainder of this act is effective when it becomes law.
