SECTION 3. Section 1 of this act becomes effective only upon the certification and 1 2 3 enrollment of the amendment upon a majority of votes cast in favor of the amendment set out in Section 1 of this act.

- 4 SECTION 4. Except as otherwise provided, this act is effective when it becomes 5 law.
