(8)	Exotic and wild animals used in traveling acts suffer severe and extended
	confinement, and, deprived of natural movements and behaviors, are prone to
	chronic stress and behavioral, health, and psychological problems.
(9)	Exotic and wild animals are forced to perform unnatural tricks requiring
	extreme physical coercion, including, but not limited to, the use of food and
	water restrictions, extended confinement, chaining, and abuse with electric
	shock devices, bullhooks, metal bars, whips, shovels, and pitchforks, among
	others.
(10)	It is not necessary to use exotic and wild animals in traveling acts to
	experience the circus or similar events.
(11)	Using exotic and wild animals as commodities traded for traveling
