	SECTION 2. The North Carolina Peer Support Specialist C	ertification Oversight
Board sha	l adopt temporary rules to implement this act. The temporary	rules shall remain in
effect until	permanent rules that replace the temporary rules become effect	ive.
	SECTION 3. The initial appointments as required by G.S. 9	00-733, as enacted by
Section 1	of this act, shall be made on or before October 1, 2021, and the	ne initial terms of the
appointees	shall begin on January 1, 2022.	
	SECTION 4. Any individual who possesses a certification	on as a peer support
specialist i	ssued by the Division of Mental Health, Developmental Disab	
Abuse Ser	vices prior to this act becoming effective shall be deemed to be in	n compliance with the
provisions	of this act for the two-year period of that individual's certificati	on. Those individuals
must com	ly with the provisions of this act when renewing their certifi	cations when this act
becomes e	fective.	
	SECTION 5. Section 1 of this act becomes effective October 1	, 2023. The remainder
	s effective when it becomes law.
