Foster Parents' Bill of Rights.

Sponsors: Referred to: May 4, 2021 A BILL TO BE ENTITLED 1 2 AN ACT TO PROVIDE A BILL OF RIGHTS RECOGNIZING THE RIGHTS OF FOSTER 3 PARENTS IN THE STATE OF NORTH CAROLINA. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1.** Article 1A of Chapter 131D of the General Statutes is amended by 6 adding a new section to read: 7 "§ 131D-10.9C. Foster parents' Bill of Rights. 8 The State recognizes the importance of foster parents in the vital role of supporting (a) children and families experiencing foster care. When children are removed from their parents or 9 10 legal guardians, families are almost immediately integrated into a team, including child welfare workers, resource parents, a guardian ad litem, attorneys, and others who are working together 11 to address the issues leading to the foster care. 12 In an effort to ensure that foster parents are treated with dignity, respect, and trust in 13 (b) their work for the Department of Health and Human Services, Division of Social Services, with 14 this team, the State supports and promotes the following for foster parents in the provision of 15 16 foster care: 17 To serve as a respected member of the child welfare team. Foster parents will (1)18 also honor children placed in their homes in accordance with G.S. 131D-10.1. 19 To receive information about the responsibilities of foster parents and access (2) 20 to support services, including all of the following: Required training and resources to ensure preparedness for caring for 21 a. children experiencing loss and trauma. 22 23 Access to the Division of Social Services and licensing agency <u>b.</u> 24 policies, including traveling with children in- and out-of-state, family visits and time, supervised and unsupervised, complaint and grievance 25 policies, and confidentiality. 26 Any known information to help better care for children, including 27 <u>c.</u> health and behavioral health history, disability, exposure to trauma, 28 and educational needs. 29 30 Additional or necessary information that the county department of <u>d</u>. 31

<u>Additional of necessary information that the county department of social services has that may be relevant to the care of the child when the child is placed with the foster parents.</u>

e. Advance notice of scheduled meetings and appointments regarding case planning and care of the child.
