A BILL TO BE ENTITLED AN ACT TO PROVIDE ADDITIONAL FLEXIBILITY TO DAVIE COUNTY SCHOOLS IN

2 3 ADOPTING THE SCHOOL CALENDAR.

4 The General Assembly of North Carolina enacts: 5

SECTION 1. G.S. 115C-84.2(d) reads as rewritten:

6 Opening and Closing Dates. - Local boards of education shall determine the dates of "(d) 7 opening and closing the public schools under subdivision (a)(1) of this section. Except for 8 year-round schools, the opening date for students shall be no earlier than the Monday closest to August 26, August 10, and the closing date for students shall be no later than the Friday closest 9 10 to June 11. On a showing of good cause, the State Board of Education may waive the requirement that the opening date for students be no earlier than the Monday closest to August 26 and may 11 12 allow the local board of education to set an opening date no earlier than the Monday closest to 13 August 19, to the extent that school calendars are able to provide sufficient days to accommodate anticipated makeup days due to school closings. A local board may revise the scheduled closing 14 date if necessary in order to comply with the minimum requirements for instructional days or 15 instructional time. For purposes of this subsection, the term "good cause" means that schools in 16 any local school administrative unit in a county have been closed eight days per year during any 17 18 four of the last 10 years because of severe weather conditions, energy shortages, power failures, 19 or other emergency situations.

20 The required opening and closing dates under this subsection shall not apply to any school 21 that a local board designated as having a modified calendar for the 2003-2004 school year or to 22 any school that was part of a planned program in the 2003-2004 school year for a system of 23 modified calendar schools, so long as the school operates under a modified calendar." 24

SECTION 2. G.S. 115C-174.12(a)(4) reads as rewritten:

"(4) All annual assessments of student achievement adopted by the State Board of Education pursuant to G.S. 115C-174.11(c)(1) and (3) and all final exams for courses shall be administered within the final 10 instructional days of the school year for year-long courses and within the final five instructional days of the semester for semester courses. Exceptions shall be permitted to accommodate a student's individualized education program and section 504 (29 U.S.C. § 794) plans and for the administration of final exams for courses with national or international curricula required to be held at designated times. A local board of education that has implemented a school calendar that

3	SECTION 3. This act applies only to Davie County Schools.
4	SECTION 4. This act is effective when it becomes law and applies beginning with
