Establish "Cops Clean NC" Grant Program for Rural Counties. - Of 32 the funds appropriated in S.L. 2020-91 from the Highway Fund to the Department of 33 Transportation for the 2020-2021 fiscal year, the Department of Transportation shall use five 34 hundred thousand dollars (\$500,000) to establish the "Cops Clean NC" grant program. The 35 Department shall award grant funds to sheriffs' offices located in rural counties to provide 36 officers overtime pay for litter cleanup efforts. The maximum grant amount for an eligible county 37 shall be no more than ten thousand dollars (\$10,000). The Department shall provide participating 38 sheriffs' offices education materials containing information on the penalties of littering and other 39 relevant information to encourage the public to keep North Carolina roads clean. These materials 40 shall be distributed to first-time offenders.
