Sponsors: Referred to: A BILL TO BE ENTITLED 2 AN ACT REMOVING THE CAP ON SATELLITE ANNEXATIONS FOR THE TOWN OF 3 WINGATE. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1.** G.S. 160A-58.1 reads as rewritten: 6 "§ 160A-58.1.
