A BILL TO BE ENTITLED

AN ACT TO MAKE CHANGES TO THE CURRENT OPERATIONS APPROPRIATIONS ACT OF 2021.

The General Assembly of North Carolina enacts:

SECTION 1.(a) Section 2.2(j) of S.L. 2021-180 reads as rewritten:

"SECTION 2.2.(j) The State Controller shall transfer the sum of ~~four hundred eleven million seven hundred sixty-nine thousand five hundred dollars (\$411,769,500)~~ four hundred thirteen million seven hundred sixty-nine thousand five hundred dollars (\$413,769,500) in nonrecurring funds for the 2021-2022 fiscal year from funds available in the State Emergency Response and Disaster Relief Reserve, to be used in accordance with Sections 5.9 and 5.9A of this act, and the funds transferred are appropriated for the fiscal year in which they are transferred."

SECTION 1.(b) Section 5.9(a) of S.L. 2021-180 reads as rewritten:

"SECTION 5.9.(a) Allocations. – The funds appropriated in Section 2.2(j) of this act for disaster relief, recovery, mitigation, and resiliency shall be allocated as follows:

...

(17) ~~\$500,000~~ Notwithstanding any provision of law or the Committee Report referenced in Section 43.2 of this act to the contrary, \$2,500,000 to the Wildlife Resources Commission for the Lake Rim Hatchery Project.

...."

SECTION 1.(c) Section 2.1(a) of S.L. 2021-180 reads as rewritten:

"SECTION 2.1.(a) Appropriations from the General Fund for the budgets of the State departments, institutions, and agencies, and for other purposes as enumerated, are made for each year of the 2021-2023 fiscal biennium, according to the following schedule:
