

#### 12 **INTRODUCTION**

13 **SECTION 1.2.** The appropriations made in this act are for maximum amounts necessary to provide the services and accomplish the purposes described in the budget in 14 15 accordance with the State Budget Act. Savings shall be effected where the total amounts 16 appropriated are not required to perform these services and accomplish these purposes, and the 17 savings shall revert to the appropriate fund at the end of the fiscal year, except as otherwise provided by law. 18
