# AN ACT TO REMOVE THE DAVIDSON COUNTY AIRPORT FROM THE CORPORATELIMITS OF THE CITY OF LEXINGTON.

SECTION 2. This act has no effect upon the validity of any liens of the City of Lexington for ad valorem taxes or special assessments outstanding before the effective date of this act. Such liens may be collected or foreclosed upon after the effective date of this act as though the property were still within the corporate limits of the City of Lexington.

31 **SECTION 3.** This act becomes effective June 30, 2022. Property in the territory 32 described in Section 1 of this act as of January 1, 2022, is no longer subject to municipal taxes 33 for taxes imposed for taxable years beginning on or after July 1, 2022.
