ACTUARIAL IMPACT SUMMARY

Systems Affected: Line of duty death benefits under Article 12A of Chapter 143 of the General Statutes

House Bill 741 (First Edition) defines telecommunicator as a person qualified to provide 911 call taking employed by a public safety answering point and extends the \$100,000 line-of-duty death benefit in Article 12A of Chapter 143 of the General Statutes to telecommunicators who die by heart attack or stroke in the course of employment or during travel to or from work.

Cavanaugh Macdonald, the actuary for the retirement systems, estimates that the numbers of qualifying deaths per year will be somewhat less than 0.04% of 3,750. Thus, the amount of additional death benefits and the needed recurring appropriation would be somewhat less than 0.04% x 3,750 x \$100,000 = \$150,000 per year.

Hartman & Associates, the actuary for the General Assembly, estimates that the bill will increase death benefits and thus the needed annual recurring appropriation by \$40,000.

For purposes of the summary table above, we have used the estimate from Hartman & Associates.

ASSUMPTIONS AND METHODOLOGY

Both actuaries used data from the U.S. Bureau of Labor Statistics and N.C. Department of Commerce on the number of telecommunicators in North Carolina and U.S. Centers for Disease Control data on the incidence of heart attack and stroke.
