FISCAL IMPACT SUMMARY

There are three types of changes to offenses: new offenses, change to offense class, or change to the scope of the offense. Section 5a of the proposed bill includes a new Class G felony offense, a change of an offense from Class 1 misdemeanor to Class G, a change of an offense from a Class H felony to a Class G, and a change to the scope of a Class G offense. Section 6 of the proposed bill includes a new Class 2 misdemeanor. Section 8 of the proposed bill includes new Class 1, Class 2, and Class 3 misdemeanors. The criminal offense modifications in the proposed bill may have a fiscal impact on the judicial and correction systems. However, due to a lack of sufficient historical data on these offense or similar offenses, the Fiscal Research Division (FRD) is unable to provide a reasonable estimate of the total fiscal impact. Each additional person charged with this crime will have a cost to the judicial system and each additional person convicted will have a cost to the correction system. All costs in the tables above have been annualized. Offense changes are typically effective on

December 1. FRD assumes that costs incurred in the first year to the judicial and correction systems would be less than annualized costs due to lag time in charges and convictions.

FISCAL ANALYSIS

General

The Sentencing and Policy Advisory Commission (SPAC) prepares prison population projections for each bill containing a criminal penalty. SPAC assumes that expanding existing or creating new criminal offenses produces no deterrent or incapacitative effect on crime rates. Likewise, FRD assumes no deterrent effects for any modifications to criminal penalties. The estimates in this Incarceration Note make no assumptions about the larger impact on crime rates or costs to society or the State.

There are three types of changes to offenses: new offenses, change to offense class, or change to the scope of the offense which may lead to an increase or decrease in the number of offenders charged. FRD assumes that new offenses and changes to an offense's scope will have no historical data upon which to estimate the number of charges or convictions that might occur. FRD assumes that a change in offense class may have an unknown effect on charge or conviction numbers. To that end, FRD estimates the average cost to the judicial and correction systems for one additional charge or conviction.

Iudicial Branch

The Administrative Office of the Courts (AOC) provides FRD with a fiscal impact analysis for most criminal penalty bills. Fiscal impact is typically based on the assumption that court time will increase due to anticipated increases in charges and corresponding increases in workload for judges, clerks, and prosecutors. This increased court time is also expected to result in greater expenditures for jury fees and indigent defense.

Section 5a of the proposed bill includes a new Class G felony offense, a change of an offense from Class 1 misdemeanor to Class G, a change of an offense from a Class H felony to a Class G, and a change to the scope of a Class G offense. Based on the AOC estimate of the average cost to the court for a charge by offense class, the average cost to the court for every additional person charged with a Class G felony would be \$1,250. The average cost to the court for every additional person charged

with a Class H felony is \$833, meaning that each new charge that will now be a Class G felony will have an average cost of \$417 more than before passage of this proposed bill (\$1,250 minus \$833). Similarly, the average cost to the court for every additional person charged with a Class 1 misdemeanor is \$274, meaning that each new charge that will now be a Class G felony will have an average cost of \$976 more than before passage of this proposed bill (\$1,250 minus \$274).

Because the annual cost of a deputy clerk is \$54,532, FRD finds that 44 charges of the new Class G offense would be equivalent to increasing the workload need of the court system by one deputy clerk. For charges that would previously have been a Class H felony, the equivalency threshold is 131 charges; for charges that would previously have been a Class 1 misdemeanor, the equivalency threshold is 56 charges.

Section 6 of the bill creates a new Class 2 misdemeanor offense. Based on the AOC estimate of the average cost to the court for a charge by offense class, the average cost to the court for every additional person charged with a Class 2 misdemeanor would be \$146. Because the annual cost of a deputy clerk is \$54,532, FRD finds that 374 charges of this new offense would be equivalent to increasing the workload need of the court system by one deputy clerk.

Section 8 of the bill creates new Class 1, Class 2, and Class 3 misdemeanor offenses. Based on the AOC estimate of the average cost to the court for a charge by offense class, the average cost to the court for every additional person charged with a Class 1 misdemeanor would be \$274. Because the annual cost of a deputy clerk is \$54,532, FRD finds that 199 charges of the new Class 1 offense would be equivalent to increasing the workload need of the court system by one deputy clerk. The average cost to the court for every additional person charged with a Class 2 misdemeanor would be \$146. Because the annual cost of a deputy clerk is \$54,532, FRD finds that 374 charges of this new offense would be equivalent to increasing the workload need of the court system by one deputy clerk. Finally, the average cost to the court for every additional person charged with a Class 3 misdemeanor would be \$52. Because the annual cost of a deputy clerk is \$54,532, FRD finds that 1,049 charges of the new Class 3 offense would be equivalent to increasing the workload need of the court system by one deputy clerk.

The Office of Indigent Defense Services (IDS) provides Fiscal Research with the frequency and cost of indigent defense services for each level of crime, including the cost differentials for district and superior court with and without a trial and the percentage of cases handled in each category. Fiscal Research uses this data to calculate a weighted average of IDS costs for each class of offense. This estimate assumes the appointment of a Private Assigned Counsel (PAC) attorney. In districts that have Public Defender (PD) offices, cases may be handled by those offices. In those instances, this cost may not be incurred, but the PD office may experience costs in terms of greater workload.

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 78% of Class G felony cases. The weighted average cost of a new Class G felony is \$632 per case for a PAC attorney.

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 78% of Class H felony cases. The weighted average cost of a new Class H felony is \$475 per case for a

PAC attorney. Therefore, the increased cost to the PAC fund for each new Class G felony that would previously have been a Class H is \$157 (\$632 - \$475).

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 39% of Class 1 misdemeanor cases. The weighted average cost of a new Class 1 misdemeanor is \$205 per case for a PAC attorney. Therefore, the increased cost to the PAC fund for each new Class G felony that would previously have been a Class 1 is \$427 (\$632 - \$205).

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 39% of Class 1 misdemeanor cases. The weighted average cost of a new Class 1 misdemeanor is \$205 per case for a PAC attorney.

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 30% of Class 2 misdemeanor cases. The weighted average cost of a new Class 2 misdemeanor is \$205 per case for a PAC attorney.

In an average based on three years of fiscal data from FY 2016-17 to FY 2018-19, IDS handled 14% of Class 3 misdemeanor cases. The weighted average cost of a new Class 3 misdemeanor is \$174 per case for a PAC attorney.

Department of Public Safety - Prisons

This bill creates a new Class G felony offense, changes a penalty from a Class H offense to a Class G felony offense and from a Class 1 offense to a Class G offense. Based on the most recent population projections and estimated bed capacity, the Prisons division will have surplus prison beds available for the five-year fiscal note horizon and beyond. Therefore, no additional prison beds will be required from the changes in this bill. SPAC provides a threshold analysis when it is not known how many offenders might be convicted and sentenced as a result of the proposed change. For each offense class, the threshold estimate is the number of convictions that result in the need for one prison bed in the first year. Because Class 1 Misdemeanors with active sentences are served in county jails, any Class G charges that would previously have been Class 1 charges will carry the same costs to the prison system as any new Class G charges.

In FY 2019-20, 40% of Class G felony convictions resulted in active sentences, with an average estimated time served of 14 months. The following table shows the estimated annual impact if there were 3 convictions (the threshold) or 20 convictions for this proposed offense per year. The five-year estimate takes into account the combination of active sentences and probation and post-release supervision violations resulting in confinement, as well as growth rates adopted by the Sentencing Commission's Forecasting Technical Advisory Group.

In FY 2019-20, 34% of Class H felony convictions resulted in active sentences, with an average estimated time served of 10 months. Impact on the prison population will occur if Class H convictions become Class G convictions under the proposed subsection because of the higher rate of active sentences (40% for Class G compared to 34% for Class H) and longer average estimated time served (14 months for Class G compared to 10 months for Class H). The following table shows the estimated annual impact if there were 4 convictions (the threshold) or 20 convictions for this proposed offense per year.

In addition to the capital costs that may be associated with additional bed needs, there are also per diem costs for housing inmates. The cost to add one additional inmate to the prison system based on FY 2019-20 expenditures is \$21.22 per day, or \$645 per month, which includes the cost of food, clothing, and health care. In FY 2019-20, 40% of Class G felony offenders received active sentences averaging 14 months. For every additional Class G felony offender receiving an active sentence, the cost to the prison section will be \$9,030 (\$645 monthly cost times 14 months). In FY 2019-20, 34% of Class H felony offenders received active sentences averaging 10 months. For every new Class G felony offender receiving an active sentence that would previously have been charged with a Class H felony, the cost to the prison section will be \$2,580 (\$9,030 - (\$645 monthly cost times 10 months)).

Department of Public Safety - Community Corrections

All felony offenders may be given exclusively active or suspended sentences or suspended in conjunction with imprisonment (split-sentence). Under S.L. 2011-192, the Justice Reinvestment Act (JRA), both community and intermediate probation may include sanctions such as electronic monitoring, short-term periods of confinement, community service, substance abuse assessment, monitoring, and treatment, or participation in educational programs or vocational skills development. Whether a probationer is subject to more stringent conditions is determined by the results of a risk-needs assessment administered by the Department of Public Safety.

Active Sentence

All active sentences for felony offenses result in a minimum of nine months of post-release supervision (PRS) for F-I level offenses. All types of PRS are supervised by the Community Corrections Section (CCS). Based on FY 2019-20 expenditures, supervision by a probation officer costs \$170 per offender per month; no cost is assumed for those receiving unsupervised probation or who are only ordered to pay fines, fees, or restitution. Total costs are based on average supervision length and the percentage of offenders (per offense class) sentenced to active sentences requiring post-release supervision and supervised probation.

For every additional Class G felony offender receiving an active sentence, the cost to CCS of nine months of PRS is \$1,530 per offender (\$170 per month times 9 months). Since Class 1

misdemeanants do not serve post-release supervision, the cost for charges that increase from Class 1 to Class G under this proposed bill will be the same as for new Class G charges: \$1,530 per offender.

For every additional Class H felony offender receiving an active sentence, the cost to CCS of nine months of PRS is \$1,530 per offender (\$170 per month times 9 months). Therefore, there is no new cost for charges that increase from Class H to Class G.

Suspended Sentence

CCS also oversees probation. In FY 2019-20, 60% of Class G felony offenders received suspended sentences. The average length of probation imposed for this offense class was 27 months. For every additional Class G felony offender receiving a non-active sentence, the average cost to CCS would be \$4,590 (\$170 per month times 27 months). Because the annual cost of a probation parole officer (PPO) is \$53,760, FRD finds that 12 convictions of this new Class G offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO.

In FY 2019-20, 66% of Class H felony offenders received suspended sentences. The average length of probation imposed for this offense class was 26 months. For every additional Class H felony offender receiving a non-active sentence, the average cost to CCS would be \$4,420 (\$170 per month times 26 months). Therefore, the cost to CCS for Class H charges that would be increased to Class G under this proposed bill is \$170 (\$4,590 - \$4,420). Because the annual cost of a PPO is \$53,760, FRD finds that 316 convictions of this changed offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO.

In FY 2019-20, 62% of Class 1 misdemeanor offenders received probation. The average length of probation imposed for this class of offense was 15 months. Therefore, at a minimum, one Class 1 misdemeanor conviction resulting in probation will require at least 15 months of supervision. The cost of 15 months of supervision is \$2,550 per offender (\$170 per month times 15 months). Because the annual cost of a PPO is \$53,760, FRD finds that 21 convictions of this new offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO. Additionally, the cost to CCS for Class 1 charges that would be increased to Class G under this proposed bill is \$2,040 (\$4,590 - \$4,420).

In FY 2019-20, 70% of Class 2 misdemeanor offenders received probation. The average length of probation imposed for this class of offense was 14 months. Therefore, at a minimum, one Class 2 misdemeanor conviction resulting in probation will require at least 14 months of supervision. The cost of 14 months of supervision is \$2,380 per offender (\$170 per month times 14 months). Because the annual cost of a PPO is \$53,760, FRD finds that 23 convictions of the new Class 1 offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO. FRD finds that 26 convictions of the changed offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO.

In FY 2019-20, 82% of Class 3 misdemeanor offenders received probation. The average length of probation imposed for this class of offense was 12 months. Therefore, at a minimum, one Class 3 misdemeanor conviction resulting in probation will require at least 12 months of supervision. The cost of 14 months of supervision is \$2,040 per offender (\$170 per month times 12 months). Because

the annual cost of a PPO is \$53,760, FRD finds that 26 convictions of this new offense resulting in a suspended sentence would be equivalent to increasing the workload need of CCS by one PPO.
