A BILL TO BE ENTITLED

2	AN ACT TO PROVIDE FOR ISSUANCE OF REPLACEMENT DATA PLATES FOR
3	LP-GAS TANKS AND TO PROVIDE FOR CIVIL PENALTIES FOR
4	VIOLATIONS OF LAW REGARDING LP-GAS.
5	The General Assembly of North Carolina enacts:
6	Section 1. Article 5 of Chapter 119 of the General Statutes is amended by
7	adding a new section to read:
8	" <u>§ 119-55.1. Replacement data plates.</u>
9	To avoid condemnation of a liquified petroleum gas tank with a rusting or partially
10	detached data plate, the Commissioner may issue a replacement data plate for tanks
11	built in accordance with the ASME Code. A fee of twenty dollars (\$20.00) shall be
12	assessed and collected for each data plate issued. These fees may be used by the
13	Department of Agriculture to defray the costs of issuing the data plates."
14	Sec. 2. G.S. 119-59 reads as rewritten:
15	"§ 119-59. Penalty; injunction of violations.
16	(a) <u>A-Any</u> dealer violating any of the provisions provision of this Article, Article
17	or any of the rules and regulations made and promulgated in accordance with the
18	provisions of this Article, shall be deemed adopted under it is guilty of a misdemeanor,
19	and upon conviction thereof shall be punished by fine or imprisonment.
20	(b) In addition the <u>The</u> Commissioner or his agent may apply to any superior court
21	judge and the court may temporarily restrain or preliminarily or permanently enjoin any
22	violation of this Article or any of the rules or regulations made and promulgated thereunder.

1	(c) <u>The Commissioner may assess a civil penalty against any person who violates</u>
2	any provision of this Article or the rules under it. The penalty shall not exceed one
3	hundred dollars (\$100.00) for the first violation, three hundred dollars (\$300.00) for a
4	second violation, or five hundred dollars (\$500.00) for a third or subsequent violation.
5	No civil penalty shall be assessed under this subsection until the person has been
6	notified in writing of the alleged violation and given 45 days to correct or cease the
7	alleged violation.
8	(d) The Commissioner may deny, suspend, modify, or revoke any registration or
9	certification issued under this Article for any violation of any provision of this Article or
10	the rules adopted under it."
