A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE BOARD OF MEDICAL EXAMINERS TO ENTER INTO PEER REVIEW AGREEMENTS WITH THE ACADEMY OF PHYSICIAN ASSISTANTS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 90-21.22 reads as rewritten:

"§ 90-21.22. Peer review agreements.

(a) The Board of Medical Examiners may, under rules adopted by the Board in compliance with Chapter 150B of the General Statutes, enter into agreements with the North Carolina Medical Society and its local medical society ~~components~~ components, and with the North Carolina Academy of Physician Assistants for the purpose of conducting peer review activities. Peer review activities to be covered by such agreements shall include investigation, review, and evaluation of records, reports, complaints, litigation and other information about the practices and practice patterns of physicians licensed by the Board, and of physician assistants approved by the Board, and shall include programs for impaired ~~physicians~~ physicians and impaired physician assistants. Agreements between the Academy and the Board shall be limited to programs for impaired physicians and physician assistants and shall not include any other peer review activities.

(b) Peer review agreements shall include provisions for the society and for the Academy to receive relevant information from the Board and other sources, conduct the

1 investigation and review in an expeditious manner, provide assurance of confidentiality
2 of nonpublic information and of the review process, make reports of investigations and
3 evaluations to the Board, and to do other related activities for promoting a coordinated
4 and effective peer review process. Peer review agreements shall include provisions
5 assuring due process.

6 (c) Each society which enters a peer review agreement with the Board shall
7 establish and maintain a program for impaired physicians licensed by the ~~Board~~Board.
8 The Academy, after entering a peer review agreement with the Board, shall either enter
9 an agreement with the North Carolina Medical Society for the inclusion of physician
10 assistants in the Society's program for impaired physicians, or shall establish and
11 maintain the Academy's own program for impaired physician assistants. The purpose of
12 the programs shall be to ~~for the purpose of identifying, reviewing, and evaluating~~ identify,
13 review, and evaluate the ability of those physicians and physician assistants to function
14 ~~as physicians~~ in their professional capacity and to provide programs for treatment and
15 rehabilitation. The Board may provide funds for the administration of impaired
16 physician and impaired physician assistant programs and shall adopt rules with
17 provisions for definitions of impairment; guidelines for program elements; procedures
18 for receipt and use of information of suspected impairment; procedures for intervention
19 and referral; monitoring treatment, rehabilitation, post-treatment support and
20 performance; reports of individual cases to the Board; periodic reporting of statistical
21 information; assurance of confidentiality of nonpublic information and of the review
22 process.

23 (d) Upon investigation and review of a physician licensed by the Board, or a
24 physician assistant approved by the Board, or upon receipt of a complaint or other
25 information, a society which enters a peer review agreement with the ~~Board~~Board, or
26 the Academy if it has a peer review agreement with the Board, as appropriate, shall
27 report immediately to the Board detailed information about any physician or physician
28 assistant licensed or approved by the Board if:

- 29 (1) The physician or physician assistant constitutes an imminent danger to
30 the public or to himself;
- 31 (2) The physician or physician assistant refuses to cooperate with the
32 program, refuses to submit to treatment, or is still impaired after
33 treatment and exhibits professional incompetence; or
- 34 (3) It reasonably appears that there are other grounds for disciplinary
35 action.

36 (e) Any confidential patient information and other nonpublic information
37 acquired, created, or used in good faith by the Academy or a society pursuant to this
38 section shall remain confidential and shall not be subject to discovery or subpoena in a
39 civil case. No person participating in good faith in the peer review or impaired
40 physician or impaired physician assistant programs of this section shall be required in a
41 civil case to disclose any information acquired or opinions, recommendations, or
42 evaluations acquired or developed solely in the course of participating in any
43 agreements pursuant to this section.

1 (f) Peer review activities conducted in good faith pursuant to any agreement
2 under this section shall not be grounds for civil action under the laws of this State and
3 are deemed to be State directed and sanctioned and shall constitute State action for the
4 purposes of application of antitrust laws."

5 Sec. 2. This act becomes effective October 1, 1993.
