5	The General Assembly of North Carolina enacts:		
6	<b>SECTION 1.</b> Chapter 168 of the General Statutes is amended by adding a		
7	new article to read:

9		"Accessible Electronic Information Act.	
10	"§ 168-30. Short title and findings.		
11	(a) Short Title. – This article shall be known and may be cited as the 'Accessible		
12	Electronic Information Act'.		
13	(b) Leg	islative Findings. – The General Assembly finds and declares all of the	
14	following:		
15	(1)	Thousands of citizens in the State have disabilities, including blindness	
16		or visual impairment, which prevent them from using conventional	
17		print material.	
18	(2)	The State fulfills an important responsibility by providing books and	
19		magazines prepared in Braille, audio, and large-type formats made	
20		available to blind and disabled persons.	
21	(3)	The technology, transcription methods, and means of distribution used	
22	<u>~~~</u>	for these materials are labor-intensive and cannot support rapid	
23		dissemination to individuals in rural and urban areas throughout the	
24		State.	
25	<u>(4)</u>	Lack of direct and prompt access to information included in	
26	<u>~~</u>	newspapers, magazines, newsletters, schedules, announcements, or	
27		other time-sensitive materials limits literacy, participation, and	
28		educational opportunities for blind and disabled persons.	

(5) This limitation can best be overcome through use of high-speed 1 2 computer and telecommunications technology, combined with 3 customized software, that provides a practical and cost-effective means to convert electronic text-based information, including daily 4 5 newspapers, into synthetic speech suitable for statewide distribution 6 with modern telecommunications technology. 7 Low-cost interstate telecommunications rates make distribution of (6) 8 electronic text-based information to blind and disabled persons both 9 efficient and cost-effective for the State. 10 (7) Federal funds have been used to develop the technology and infrastructure needed for statewide toll-free access to daily newspapers 11 12 and other timely information of local, State, and national interest, providing an efficient and cost-effective means of reader registration, 13 14 content acquisition, and interstate telecommunications support. 15 (8) Use of this accessible electronic information service will enhance the State's current efforts to meet the needs of blind and disabled persons 16 17 for access to information that is otherwise available in print, reducing 18 isolation and supporting full integration and equal access for these 19 persons. 20 **"§ 168-31. Definitions.** 21 The following definitions apply in this section: Accessible electronic information service. – A service where news and 22 (1) 23 other timely information, including newspapers, is provided to blind 24 and disabled persons from a multistate service center, using high-speed computers and telecommunications technology for interstate 25 acquisition of content and rapid distribution in a form appropriate for 26 27 use by blind and disabled persons.
