## A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA FOR THE BRODY SCHOOL OF MEDICINE AT EAST CAROLINA UNIVERSITY TO CONSTRUCT A FAMILY MEDICINE CENTER.

Whereas, the current Eastern Carolina Family Practice Center at the Brody School of Medicine at East Carolina University was constructed in 1975 and since that time has been the training home for more than 250 family doctors, most of whom practice in North Carolina; and

Whereas, in any accredited residency training program for family medicine, the "Center" is the centerpiece; and

Whereas, the "Center" is as important to the family physicians as state-of-the-art operating rooms are to the training of surgeons; and

Whereas, the Eastern Carolina Family Practice Center is outdated and overcrowded, and therefore the Department of Family Medicine can no longer effectively compete in the recruitment of residents, fellows, and faculty; and

Whereas, inadequate facilities represent a challenge to delivery of quality care for our citizenry; and

Whereas, states with the highest number of "general practitioners" per 1,000 patients rank significantly higher, both in terms of quality and cost-effectiveness of health care; and

Whereas, without a new Family Medicine Center at the Brody School of Medicine, a population of people with some of the worst health indicators in the nation is going to be even more threatened; and

Whereas, family physicians receive four years of medical school education followed by a minimum of three years of specialty training; and

The General Assembly of North Carolina enacts:

**SECTION 1.** There is appropriated from the General Fund to the Board of Governors of The University of North Carolina for the Brody School of Medicine the sum of forty million dollars (\$40,000,000) for the 2005-2006 fiscal year to construct the Family Medicine Center at the Brody School of Medicine at East Carolina University.
